The *Corporations Amendment (Meetings and Documents) Act 2022* (**Amendment Act**) includes a new requirement for public companies and listed companies to give shareholders notice of their right to elect to be sent documents electronically or physically by the company in section 110K of the Corporations Act.

The entity will disregard any votes cast in favour of Resolution 7 by or on behalf of any person who participated in the issue or an associate of that person/persons.

However, this does not apply to a vote cast in favour of a resolution by:

- (a) a person as proxy or attorney for a person who is entitled to vote on the resolution, in accordance with directions given to the proxy or attorney to vote on the resolution in that way; or

Dr Changshun Jia (or their nominee) and any other person who will obtain a material benefit as a result of the issue of the securities (except a benefit solely by reason of being a holder of ordinary securities in the Company) or an associate of that person or those persons.

However, this does not apply to a vote cast in favour of this resolution by:

- (a) a person as proxy or attorney for a person who is entitled to vote on the resolution, in accordance with directions given to the proxy or attorney to vote on the resolution in that way; or

#### **Resolution 9 – Approval of 10% Placement Capacity**

To consider and, if thought fit, to pass the following as a **special resolution**:

"That, for the purposes of Listing Rule 7.1A and for all other purposes, approval is given for the Company to issue up to that number of Equity Securities equal to 10% of the issued capital of the Company at the time of issue, calculated in accordance with the formula prescribed in ASX Listing Rule 7.1A.2 and otherwise on the terms and conditions set out in the Explanatory Memorandum."

#### Voting Exclusion:

The entity will disregard any votes cast in favour of this resolution by or on behalf of:

- (a) A person who is expected to participate in, or will obtain a material benefit as a result of, the proposed issue (except a benefit solely by reason of being a holder or ordinary securities in the entity) or

**Important Note**: At the date of this Notice, the proposed allottees of the securities are not as yet known or identified. For a person's vote to be excluded, it must be known that person will participate in the proposed issue. Where it is not known who will participate in the proposed issue, Shareholders must consider the proposal on the basis that they may or may not get a benefit and that it is possible that their holding will be diluted and there is no reason to exclude their votes.

- the proxy need not be a Shareholder of the Company; and
- a Shareholder who is entitled to cast two or more votes may appoint two proxies and may specify the proportion or number of votes each proxy is appointed to exercise.

#### **CORPORATE REPRESENTATIVES**

A body corporate that is a Shareholder, or which has been appointed as proxy, may appoint an individual to act as its representative at the Annual General Meeting. The appointment must comply with the requirements of section 250D of the Corporations Act. The representative should bring to the meeting evidence of his or her appointment, including any authority under which it is signed, unless it has previously been given to the Company.

#### DATE FOR DETERMINING HOLDERS OF SHARES

In accordance with Regulation 7.11.37 of the *Corporations Regulations 2001* (Cth), the Directors have set a date to determine the identity of those entitled to attend and vote at the Annual General Meeting. # EXPLANATORY MEMORANDUM TO SHAREHOLDERS

## 1. ACTION TO BE TAKEN BY SHAREHOLDERS

This Explanatory Memorandum sets out information about the Resolutions to be considered by the Shareholders at the Annual General Meeting. Defined terms used in this Explanatory Memorandum are set out in Section 11. Accompanying this Explanatory Memorandum is the Notice of Annual General Meeting convening the Annual General Meeting and a Proxy Form.

Shareholders are encouraged to attend and vote on the Resolutions to be put to the Annual General Meeting. If a Shareholder is not able to attend and vote at the Annual General Meeting, the Shareholder may complete the Proxy Form and return it not later than 48 hours before the time specified for the commencement of the Annual General Meeting.

## 2. ANNUAL FINANCIAL REPORTS

The Corporations Act requires the Company's financial statements and reports of the Directors and of the auditor for the year ended 30 June 2023 to be laid before the Annual General Meeting. The financial statements and the reports of the Directors and of the auditor are contained in the Company's 2023 Annual Report, a copy of which is available on the Company's website at www.enterprisemetals.com.au.

Whilst no Resolution is required in relation to this item, Shareholders should consider the documents and raise any matters of interest with the Directors when this item is being considered.

A representative from the Company's auditors will be invited to the meeting and Shareholders will have an opportunity to ask the auditor questions in relation to the conduct of the audit, the auditor's report, the Company's accounting policies and the independence of the auditor.

#### 3. RESOLUTION 1: ADOPTION OF REMUNERATION REPORT

The Remuneration Report is required to be considered for adoption in accordance with section 250R of the Corporations Act. The Remuneration Report sets out the Company's remuneration arrangements for the Directors and senior management of the Company. The Remuneration Report is part of the Directors' Report contained in the annual financial report of the Company for the financial year ending 30 June 2023.

A reasonable opportunity will be given for the discussion of the Remuneration Report at the Annual General Meeting. Shareholders should note that the vote on this Resolution is advisory only and does not bind the Company or the Directors.

The Company's Shareholders have approved the Remuneration Report at each previous annual general meeting.

The Chairman intends to exercise all undirected proxies in favour of Resolution 1. If the Chairman of the Annual General Meeting is appointed as your proxy and you have not specified the way the Chairman is to vote on Resolution 1, by signing and returning the Proxy Form, the Shareholder is considered to have provided the Chairman with an express authorisation for the Chairman to vote the proxy in accordance with the Chairman's intention.

# 4. RESOLUTION 2: ELECTION OF DIRECTOR – GRAEME SMITH

#### 4.1 Background for Resolution

In accordance with clause 7.3(c) of the Constitution and ASX Listing Rule 14.4, Graeme Smith is required to retire and being eligible for election, offers himself for re-election.

Mr Smith was appointed Company Secretary on 22 March 2019 and subsequently appointed as a Non-Executive Director on 10 July 2023. Mr Smith is a corporate governance & finance professional with over 25 years' experience in accounting and company administration. He is a Fellow of the Australian Society of Certified Practicing Accountants, the Institute of Chartered Secretaries and Administrators and the Governance Institute of Australia. He is the principal of Wembley Corporate which provides Company Secretarial, CFO, and Corporate Governance services to public and private companies. Graeme Smith is currently a director of Augustus Minerals Limited.

Mr Smith is considered by the Board to be an independent Director.

# 4.2 Directors' Recommendation

The Directors (other than Mr Smith) unanimously supports the re-election of Mr Smith.

## 5. RESOLUTION 3 – RE-ELECTION OF DIRECTOR – DERMOT RYAN

#### 5.1 Background

In accordance with clause 7.3(a) of the Constitution and ASX Listing Rule 14.5, Dermot Ryan is required to retire and being eligible for election, offers himself for re-election.

Mr Ryan spent 20 years with CRA Ltd from 1977-1996, including 10 years as Chief Geologist for CRA Exploration in various states of Australia. He was General Manager Exploration for Great Central Mines Ltd (later Normandy Yandal Operations Ltd) and Johnsons Well Mining NL (now Regis Resources Ltd) from late 1996-2000 and provided geological consulting services to Mark Creasy from 2001 to 2008, before founding Enterprise. For the past 14 years he has been a Director of private mineral exploration consulting company XServ Pty Ltd and for the past 2 years he has been a Director of Montana Exploration Services Pty Ltd. He is a Fellow of the AusIMM, (CP Geo), a Fellow of the AIG, and holds a BApSc (Geol).

Dermot Ryan is considered by the Board to be an independent Director.

#### 5.2 Directors' Recommendation

The Directors (other than Mr Ryan) unanimously supports the election of Mr Ryan.

#### 6. **RESOLUTION 4: Ratification of Prior Issue – Mandilla Option Agreement Shares (LR 7.1)**

#### 6.1 Background and Summary of Option Agreement

As announced on 17 March 2020, the Company entered into an Option Agreement with Mrs Vera Olive Allen (**Owner**) to purchase the Mandilla Gold Prospect (**Option**). The Mandilla Gold Prospect consists of two granted tenements, Exploration Licence 15/1437 and Prospecting Licence 15/5885 (**Tenements**).

The Company paid \$20,000 cash as consideration for the initial 18-month Option (**Option Period**). Pursuant to the terms of the Option Agreement, the Company elected to extend the Option Period for an additional 18 months and paid \$40,000 in cash as consideration for the extension of the Option Period.

An exclusive licence was granted to the Company during the Option Period under the Option Agreement to enter, traverse and remain on the Tenements in order to carry out exploration on the Tenements and view and observe any activities carried out by the Owner on the Tenements. This grant of licence was subject to a number of conditions, including the requirement for the Company to meet expenditure obligations under the Mining Act, prepare and lodge all programme of works with respect to the Tenements, prepare applications and approvals for all activities on the Tenements, provide the Owner with relevant information to enable her to meet reporting obligations under the Mining Act, provide, supply, mobilise and install all plant and equipment, services and utilities to enable proper performance of its activities on the Tenements, comply with all relevant legislation and regulations, maintain all necessary insurance in connection with proposed activities of the Company on the Tenements and pay the option royalty to the Owner within 14 days of the end of each quarter.

The obligation to pay the option royalty to the Owner was calculated on the basis of 1.5% of the value of minerals obtained from the Tenements from the commencement of the Option Period to the exercise of the Option. No option royalty has been paid.

The Company exercised the Option to acquire the Tenements on XX and paid the following consideration as required under the Option Agreement:

- (a) \$100,000 (plus GST) in cash; and
- (b) the issue of \$100,000 worth of Shares. Under the Option Agreement, the issue price of the Shares was calculated based on the 5-day volume weighted average market price of the Shares, with the 5-day period commencing on the day immediately prior to the exercise of the Option. This equated to 24,390,244 Shares at a deemed issue price of \$0.004 per share.

Following acquisition of the Tenements, the Company is now required to pay a royalty to the Owner of 1.5% of the value of minerals obtained from the Tenements as a result of hard rock production, capped at \$1 million.

The Company issued the Shares without prior Shareholder approval under Listing Rule 7.1.

Resolution 4 seeks Shareholder approval pursuant to Listing Rule 7.4 for the ratification of the issue of the Shares.

Resolution 4 is an ordinary resolution.

# 6.2 ASX Listing Rule 7.1

ASX Listing Rule 7.1 provides that a company must not, subject to specified exceptions, issue or agree to issue more equity securities during any 12 month period than that amount which represents 15% of the number of fully paid ordinary securities on issue at the commencement of that 12 month period.

ASX Listing Rule 7.4 sets out an exception to ASX Listing Rule 7.1. It provides that where a company in general meeting ratifies the previous issue of securities made pursuant to ASX Listing Rule 7.1 (and provided that the previous issue did not breach ASX Listing Rule 7.1) those securities will be deemed to have been made with shareholder approval for the purpose of ASX Listing Rule 7.1.

By ratifying this issue the subject of Resolution 4, the Company will retain the flexibility to issue equity securities in the future up to the 15% annual placement capacity set out in ASX Listing Rule 7.1 without the requirement to obtain prior Shareholder approval. The Company confirms that the issue and allotment of the Shares, the subject of Resolution 4 did not breach ASX Listing Rule 7.1.

If Resolution 4 is not passed the issue of the Shares is still valid however it will reduce, to that extent, the Company's capacity to issue equity securities without shareholder approval under Listing Rule 7.1 for 12 months following the issue.

# 6.3 ASX Listing Rule 7.5

The following information is provided to Shareholders for the purposes of obtaining Shareholder approval of the share issue the subject of Resolution 4 in accordance with ASX Listing Rule 7.5:

- (a) the Shares were issued to Ronald William Allen, Peter Thomas Allen and Jeffrey Gordon Allen, as the Executors for the deceased estate of Vera Olive Allen, which are not related parties of the Company;
- (b) 24,390,244 fully paid ordinary Shares were issued;
- (c) the Shares were issued and allotted on 19 June 2023;
- (d) the Shares were issued at a deemed issue price of \$0.004 each, calculated in accordance with the Option Agreement described in Section 6.1 above;
- (e) the Shares are fully paid ordinary Shares in the capital of the Company, ranking equally in all respects with the Company's existing Shares on issue;
- (f) no funds were raised from the issue as the Shares were issued as part consideration under the Option Agreement, a summary of which is provided in Section 6.1 above; and
- (g) a voting exclusion statement is included in the Notice.

#### 6.4 Directors' Recommendation

The Directors of the Company believe that Resolution 4 is in the best interests of the Company and unanimously recommend that Shareholders vote in favour of Resolution 4.

#### 7. RESOLUTION 5: Ratification of Prior Issue – Placement Shares and Placement Options A (LR 7.1)

#### 7.1 Background

The Company undertook a private placement to sophisticated and professional investors to raise funds for working capital purposes through the issue of a total of 20,000,000 Shares at 0.005 each, with one free attaching option for every share subscribed for, exercisable at \$0.0075 each and expiring on 30 June 2025 (**Placement Options A**).

The Company issued the Shares and Placement Options A without prior Shareholder approval under Listing Rule 7.1.

Resolution 5 seeks Shareholder approval pursuant to Listing Rule 7.4 for the ratification of the issue of the Shares and Placement Options A.

Resolution 5 is made up of two separate, ordinary resolutions.

# 7.2 ASX Listing Rule 7.1

ASX Listing Rule 7.1 provides that a company must not, subject to specified exceptions, issue or agree to issue more equity securities during any 12 month period than that amount which represents 15% of the number of fully paid ordinary securities on issue at the commencement of that 12 month period.

ASX Listing Rule 7.4 sets out an exception to ASX Listing Rule 7.1. It provides that where a company in general meeting ratifies the previous issue of securities made pursuant to ASX Listing Rule 7.1 (and provided that the previous issue did not breach ASX Listing Rule 7.1) those securities will be deemed to have been made with shareholder approval for the purpose of ASX Listing Rule 7.1.

By ratifying this issue the subject of Resolutions 5(a) and 5(b), the Company will retain the flexibility to issue equity securities in the future up to the 15% annual placement capacity set out in ASX Listing Rule 7.1 without the requirement to obtain prior Shareholder approval. The Company confirms that the issue and allotment of the Shares, the subject of Resolutions 5(a) and 5(b) did not breach ASX Listing Rule 7.1.

If Resolutions 5(a) and 5(b) are not passed the issue of the Shares is still valid however it will reduce, to that extent, the Company's capacity to issue equity securities without shareholder approval under Listing Rule 7.1 for 12 months following the issue.

# 7.3 ASX Listing Rule 7.5

The following information is provided to Shareholders for the purposes of obtaining Shareholder approval of the share issue, the subject of Resolutions 5(a) and 5(b) in accordance with ASX Listing Rule 7.5:

- (a) the Shares and Placement Options A were issued as follows:
  - a. 10,000,000 Shares and 10,000,000 Placement Options A were issued to Mr Robert McKenna (of which, ratification is sought under Resolution 5(a)); and
  - b. 10,000,000 Shares and 10,000,000 Placement Options A were issued to Ms Lois Blackwood (of which, ratification is sought under Resolution 5(b)),

both of which are not related parties of the Company;

- (b) 20,000,000 fully paid ordinary Shares were issued and 20,000,000 Placement Options A were issued;
- (c) the Shares are fully paid ordinary Shares in the capital of the Company, ranking equally in all respects with the Company's existing Shares on issue. The Placement Options A were issued on the terms and conditions as set out in Schedule 1;
- (d) the Shares and Placement Options A were issued and allotted on 10 July 2023;
- (e) the Shares were issued at \$0.005 each. The Placement Options A were free-attaching options and therefore nil consideration was paid for the Placement Options A, issued on the basis of 1 free attaching Placement Option A for every share subscribed for;
- (f) a total of \$100,000 in capital was raised from the issue of the Shares and Placement Options A. The funds were raised to use for short-term working capital purposes such as this was used for exploration activities such as drilling, assaying and sampling at the Company's projects, and for general working capital; and
- (g) a voting exclusion statement is included in the Notice.

#### 7.4 Directors' Recommendation

The Directors of the Company believe that Resolution 5 is in the best interests of the Company and unanimously recommend that Shareholders vote in favour of both resolutions forming Resolution 5.

# 8. RESOLUTION 6 & 7: Ratification of Prior Issue – Placement Shares and Placement Options B (LR 7.1 and 7.1A)

#### 8.1 Background

The Company undertook a private placement to sophisticated and professional investors to raise funds for working capital purposes through the issue of a total of 50,000,000 Shares and 50,000,000 free-attaching options, exercisable at \$0.0075 each and expiring on 30 July 2025 (**Placement Options B**).

The Company issued 40,000,000 Placement Options B without prior Shareholder approval under Listing Rule 7.1 (ratification of which is sought under Resolution 6). The Company issued 50,000,000 Shares and 10,000,000 Placement Options B without prior Shareholder approval under the Company's Listing Rule 7.1A placement capacity (ratification of which is sought under Resolution 7).

Resolutions 6 and 7 seek Shareholder approval pursuant to Listing Rule 7.4 for the ratification of the issue of the Shares.

Resolutions 6 and 7 are ordinary resolutions.

# 8.2 ASX Listing Rules 7.1 and 7.1A

ASX Listing Rule 7.1 provides that a company must not, subject to specified exceptions, issue or agree to issue more equity securities during any 12 month period than that amount which represents 15% of the number of fully paid ordinary securities on issue at the commencement of that 12 month period.

Under Listing Rule 7.1A, a company can seek approval from its shareholders, by way of a special resolution passed at its annual general meeting, to increase this 15% placement capacity limit by an extra 10% to 25%.

The Company obtained approval to increase its placement capacity limit to 25% at the annual general meeting held on 1 November 2022.

ASX Listing Rule 7.4 sets out an exception to ASX Listing Rule 7.1. It provides that where a company in general meeting ratifies the previous issue of securities made pursuant to ASX Listing Rule 7.1 (and provided that the previous issue did not breach ASX Listing Rule 7.1) those securities will be deemed to have been made with shareholder approval for the purpose of ASX Listing Rule 7.1.

By ratifying this issue of the Shares and Placement the subject of Resolutions 6 and 7, the Company will retain the flexibility to issue equity securities in the future up to the 25% annual placement capacity set out in ASX Listing Rule 7.1 without the requirement to obtain prior Shareholder approval. The Company confirms that the issue and allotment of the Shares, the subject of Resolutions 6 and 7 did not breach ASX Listing Rule 7.1.

If Resolutions 6 and 7 are not passed, the issue of the Shares and Placement Options B is still valid however it will reduce, to that extent, the Company's capacity to issue equity securities without shareholder approval under Listing Rule 7.1 for 12 months following the issue.

# 8.3 ASX Listing Rule 7.5

The following information is provided to Shareholders for the purposes of obtaining Shareholder approval of the share issue, the subject of Resolutions 6 and 7 in accordance with ASX Listing Rule 7.5:

- (a) the Shares and Placement Options B were issued as follows:
  - i. 40,000,000 Placement Options B were issued under the Company's placement capacity pursuant to ASX Listing Rule 7.1 (ratification of which is sought under Resolution 6); and
  - ii. 50,000,000 Shares and 10,000,000 Placement Options B were issued under the Company's placement capacity pursuant to ASX Listing Rule 7.1A (ratification of which is sought under Resolution 7),

to Vulcan Development Limited, which is not a related party of the Company.

- (b) the Shares are fully paid ordinary Shares in the capital of the Company, ranking equally in all respects with the Company's existing Shares on issue. The Placement Options B were issued on the same terms and conditions as set out in Schedule 2;
- (c) the Shares and Placement Options B were issued and allotted on 8 August 2023;
- (d) the Shares the subject of Resolution 7 were issued at \$0.005 each. The Placement Options B the subject of Resolutions 6 and 7 were free-attaching options, and therefore nil consideration was paid for the Placement Options B, issued on the basis of 1 free attaching Placement Option B for every Share subscribed for;
- (e) a total of \$250,000 in capital was raised from the issue of the Shares and Placement Options B issued under the Company's Listing Rule 7.1A capacity. The funds were raised to use for short-term working capital purposes to be used for exploration activities such as drilling, assaying and sampling at the Company's projects, and for general working capital; and
- (f) a voting exclusion statement is included in the Notice.

#### 8.4 Directors' Recommendation

The Directors of the Company believe that Resolutions 6 and 7 are in the best interests of the Company and unanimously recommend that Shareholders vote in favour of Resolutions 6 and 7.

# 9. RESOLUTION 8 – ISSUE OF OPTIONS TO DIRECTORS

#### 9.1 Background

Resolution 8, comprising three separate resolutions, seeks Shareholder approval for the issue of Options to executive and non-executive directors, comprising a total of 30,000,000 Options as follows:

(a) 10,000,000 Options to Graeme Smith (or his respective nominee/s), the subject of Resolution 8(a);

(b) 10,000,000 Options to Dermot Ryan (or his respective nominee/s), the subject of Resolution 8(b); and

(c) 10,000,000 Options to Dr Changshun Jia (or his respective nominee/s), the subject of Resolution 8(c);

together, the "Directors' Options".

# 9.2 Chapter 2D of the Corporations Act

Section 195(1) of the Corporations Act provides that a director who has a "material personal interest" in a matter being considered at a directors' meeting must not be present while the matter is being considered or vote on the matter. Section 195(4) of the Corporations Act provides that where there are insufficient directors to form a quorum at a directors' meeting because of section 195(1), the directors may call a Meeting of shareholders to consider the matter. The Directors are unable to form a quorum to consider any matters relating to the proposed issue of Options under Resolutions 8(a) to 8(c), as Graeme Smith, Dermot Ryan and Dr Changshun Jia, being all of the Directors of the Company, have a material personal interest in the outcome of Resolutions 8(a) to 8(c). Therefore, the Company is also seeking Shareholder approval under section 195(4) of the Corporations Act.

# 9.3 Chapter 2E of the Corporations Act

For a public company, or an entity that the public company controls, to give a financial benefit to a related party of the public company, the public company must:

- (a) obtain the approval of the public company's members in the manner set out in sections 217 to 227 of the Corporations Act; and
- (b) give the benefit within 15 months following such approval,

unless the giving of the financial benefit falls within an exception set out in sections 210 to 216 of the Corporations Act.

The issue of the Directors' Options constitutes giving a financial benefit and each of the parties the subject of Resolution 8 are related parties of the Company by virtue of being a Director.

In respect of Resolution 8(a), the Directors (other than Graeme Smith who has a material personal interest in Resolution 8(a)), consider that Shareholder approval pursuant to Chapter 2E of the Corporations Act is not required because the agreement to issue 10,000,000 Options to Non-Executive Chair, Graeme Smith, constitutes reasonable remuneration.

In respect of Resolution 8(b), the Directors (other than Dermot Ryan who has a material personal interest in Resolution 8(b)), consider that Shareholder approval pursuant to Chapter 2E of the Corporations Act is not required because the agreement to issue 10,000,000 Options to Executive Director, Dermot Ryan, constitutes reasonable remuneration.

In respect of Resolution 8(c), the Directors (other than Dr Changshun Jia who has a material personal interest in Resolution 8(c)), consider that Shareholder approval pursuant to Chapter 2E of the Corporations Act is not required because the agreement to issue 1,250,000 Options to Non-Executive Director, Dr Changshun Jia, constitutes reasonable remuneration.

# 9.4 Listing Rule 10.11

Listing Rule 10.11 provides that unless one of the exceptions in Listing Rule 10.12 applies, a listed company must not issue or agree to issue equity securities to:

- (a) a related party (Listing Rule 10.11.1);
- (b) a person who is, or was at any time in the 6 months before the issue or agreement, a substantial (30%+) holder in the company (Listing Rule 10.11.2);
- (c) a person who is, or was at any time in the 6 months before the issue or agreement, a substantial (10%) holder in the company and who has nominated a director to the board of the company pursuant to a relevant agreement which gives them a right or expectation to do so (Listing Rule 10.11.3);
- (d) an associate of a person referred to in Listing Rules 10.11.1 to 10.11.3 (Listing Rule 10.11.4); or
- (e) a person whose relationship with the company or a person referred to in Listing Rules 10.11.1 to 10.11.4 is such that, in ASX's opinion, the issue or agreement should be approved by its shareholders (Listing Rule 10.11.5),

unless it obtains the approval of its shareholders.

The Directors the subject of Resolutions 8(a) to 8(c) fall within Listing Rule 10.11.1 and do not fall within any of the exceptions in Listing Rule 10.12. Therefore Resolutions 8(a) to 8(c) require the approval of Shareholders under Listing Rule 10.11.

## 9.5 Technical Information Required by Listing Rule 14.1A

If each of Resolutions 8(a) to 8(c) are passed, the Company will be able to proceed with the issue of the Directors' Options within one month after the date of the Meeting (or such later date as permitted by any ASX waiver or modification of the Listing Rules).

As approval pursuant to Listing Rule 7.1 is not required for the issue of the Directors' Options (because approval is being obtained under Listing Rule 10.11), the issue of the Directors' Options will not use up any of the Company's 15% annual placement capacity.

If any of Resolutions 8(a) to 8(c) are not passed, the Company will not be able to proceed with the issue of the Directors' Options for the respective Resolution and the Company may consider other mechanisms to reasonably remunerate and incentivise the respective Director.

Resolution 8 is made up of three separate ordinary resolutions which are not dependent on each other.

#### 9.6 Technical Information required by Listing Rule 10.13

Pursuant to and in accordance with Listing Rule 10.13, the following information is provided in relation to Resolutions 8(a) to 8(c):

- (a) The Directors' Options will be issued to the Directors as follows:
  - (i) 10,000,000 Options to Graeme Smith (or his respective nominee/s), the subject of Resolution 8(a);
  - (ii) 10,000,000 Options to Dermot Ryan (or his respective nominee/s), the subject of Resolution 8(b); and
  - (iii) 10,000,000 Options to Dr Changshun Jia (or his respective nominee/s), the subject of Resolution 8(c).

each of which fall within the category set out in Listing Rule 10.11.1 as each proposed allottee of the Directors' Options is a related party of the Company by virtue of being a Director of the Company.

- (b) A maximum of 30,000,000 Directors' Options will be issued to the Directors (or their respective nominees) in the amounts described in paragraph (a) above.
- (c) The Directors' Options will be issued for nil consideration as the Directors' Options constitute incentives for the Directors in their current directorship role with the Company, accordingly no funds will be raised.
- (d) The exercise price of the Directors' Options is \$0.006 each, unless a cashless exercise is utilised as detailed in (i) below. The Directors' Options expire 3 years from the date of their issue.
- (e) The terms and conditions of the Directors' Options are set out in Annexure A to this Notice. The Directors' Options contain a vesting condition which requires there being a 100% increase in the Company's Share price from the 20-Day VWAP prior to the date of the issue of the Incentive Options (Vesting Condition).
- (f) The shares issued following exercise of a Directors' Option will be fully paid ordinary shares and will rank equally with other shares on issue at the time of exercising the Directors' Option.
- (g) If Resolution 8 is passed, the Company will issue the Directors' Options within 1 month of the date of the Meeting (or such later date to the extent permitted by any ASX waiver or modification of the Listing Rules) and it is intended that issue of the Directors' Options will occur on the same date (or as soon as practicable thereafter).
- (h) The Directors' Options forms part of each Directors' reasonable remuneration. The Company considers the Directors' Options as a reasonable and cost-effective way to incentivise Directors. In addition, the vesting of the Directors' Options are tied to the Vesting Condition which is directly linked to the Company's share price over a 5 day period.
- No funds will be raised from the issue of the Directors' Options. If the Directors' Options are all exercised, \$180,000 will be raised through the payment of the exercise price, being \$0.006 per Directors' Option, unless a cashless exercise is utilised.

The cashless exercise facility allows the Director to exercise the Options without payment of the exercise price (**Cashless Exercise Facility**). Where the Cashless Exercise Facility is utilised, the Director would only be issued or transferred that lesser number of Shares as is equal in value to the difference between the exercise price and the market value of the Shares at the time of exercise in accordance with the following formula:

$$S = \frac{O \times (MV - OEP)}{MV}$$

S = the number of Shares to be issued to the Director on exercise of Options using the Cashless Exercise Facility.

O = the number of Options exercised by the Director using the Cashless Exercise Facility.

MV = the VWAP per Share during the five trading days ending on the day before the time of exercise using the Cashless Exercise Facility.

OEP = the Exercise Price per Option of the Options exercised using the Cashless Exercise Facility

(j) Directors current remuneration is:

(k) A voting exclusion notice is included with this Notice.

#### 9.7 Directors' recommendation

Each Director declines to make a recommendation to Shareholders in relation to Resolutions 8(a) to 8(c), due to their material personal interest in the outcome of the Resolutions on the basis that each Director is to be issued Director Options should Resolutions 8(a) to 8(c) be passed.

# 10. RESOLUTION 9 – APPROVAL OF 10% PLACEMENT CAPACITY

#### 10.1 Background

Listing Rule 7.1 requires Shareholder approval for an issue of securities in the Company if that issue will, when aggregated with all other issues during the previous 12 months, exceed 15% of the number of securities on issue at the commencement of that 12 month period.

In accordance with Listing Rule 7.1A, eligible entities may seek Shareholder approval at their annual general meeting to issue a further 10% of their issued share capital in addition to the 15% placement capacity set out in Listing Rule 7.1 (**10% Share Issue Capacity**).

An eligible entity for the purposes of Listing Rule 7.1A is an entity that is not included in the S&P/ASX 300 Index and has a market capitalisation of \$300 million or less. The Company is an eligible entity.

Any issue of securities under Listing Rule 7.1A:

- (a) must be in the same class as an existing quoted class of the Company's equity securities;
- (b) may be issued at a maximum of 25% discount to the current market price; and
- (c) must be calculated in accordance with the formula prescribed by Listing Rule 7.1A.2.

The Company is now seeking Shareholder approval by way of a Special Resolution to have the ability to issue equity securities under the 10% Share Issue Capacity. The approval of Resolution 9 will provide the Company with even greater flexibility to issue securities under the 10% Share Issue Capacity in addition to the 15% placement capacity set out in Listing Rule 7.1 without a further requirement to obtain prior Shareholder approval.

Resolution 9 is a Special Resolution and therefore requires the approval of 75% of the votes cast by Shareholders present and eligible to vote (in person, by Proxy, by attorney or, in the case of a corporate Shareholder, by a corporate representative).

The Chair intends to exercise all available proxies in favour of Resolution 9.

If Resolution 9 is approved as a special resolution, the Company will be able to issue 'equity securities' under Listing Rule 7.1 and 7.1A without further shareholder approval such that the Company's total annual placement capacity will be 25% of its issued capital.

If Resolution 9 is not passed, the Company will not be able to access the additional 10% capacity to issue equity securities without shareholder approval provided for in Listing Rule 7.1 and will remain subject to the 15% limit on issuing equity securities without shareholder approval set out in Listing Rule 7.1.

# 10.2 Technical information required by ASX Listing Rule 7.1A

Pursuant to and in accordance with Listing Rule 7.3A, the information below is provided in relation to this Resolution:

## (a) **Period for which the 7.1A Mandate is valid**

The 7.1A Mandate will commence on the date of the Meeting and expire on the first to occur of the following:

- (i) the date that is 12 months after the date of this Meeting;
- (ii) the time and date of the Company's next annual general meeting; and
- (iii) the time and date of approval by Shareholders of any transaction under Listing Rule 11.1.2 (a significant change in the nature or scale of activities) or Listing Rule 11.2 (disposal of the main undertaking).

#### (b) Minimum Price

Any Equity Securities issued under the 7.1A Mandate must be in an existing quoted class of Equity Securities and be issued at a minimum price of 75% of the volume weighted average price of Equity Securities in that class, calculated over the 15 trading days on which trades in that class were recorded immediately before:

- (i) the date on which the price at which the Equity Securities are to be issued is agreed by the entity and the recipient of the Equity Securities; or
- (ii) if the Equity Securities are not issued within 10 trading days of the date in Section (b)(ii), the date on which the Equity Securities are issued.

#### (c) Use of funds raised under the 7.1A Mandate

The Company will only issue Shares under the 10% Share Issue Capacity for cash consideration.

The Company intends to use the funds raised towards the acquisition of new assets or investments (including expenses associated with such acquisition), further development of the Company's projects and/or for general working capital purposes.

The reasons for undertaking any particular issue under the 10% Share Issue Capacity would be announced at the time the Company sought to issue shares under that 10% Share Issue Capacity.

#### (d) Risk of Economic and Voting Dilution

Any issue of Equity Securities under the 7.1A Mandate will dilute the interests of Shareholders who do not receive any Shares under the issue.

If this Resolution is approved by Shareholders and the Company issues the maximum number of Equity Securities available under the 7.1A Mandate, the economic and voting dilution of existing Shares would be as shown in the table below.

The table below shows the dilution of existing Shareholders calculated in accordance with the formula outlined in Listing Rule 7.1A.2, on the basis of the closing market price of Shares and the number of Equity Securities on issue as at 19 October 2023.

The table also shows the voting dilution impact where the number of Shares on issue (Variable A in the formula) changes and the economic dilution where there are changes in the issue price of Shares issued under the 7.1A Mandate.

As required by the Listing Rules, the table below shows a hypothetical example of the potential dilution of Shareholders of the Company where the full 10% Share Issue Capacity is utilised, on the basis of three different assumed issue prices and numbers of equity securities on issue.

The Company previously obtained approval under ASX Listing Rule 7.1A at its last annual general meeting on 1 November 2022.

Below are the details required under Listing Rule 7.3A.6:

(i) the total number of Equity Securities issued in the 12 months preceding the date of this Notice of Meeting under LR 7.1A.2 was 50,000,000 Shares and 10,000,000 Placement Options B (ratification of which is sought under Resolution 7), representing a total of 60,000,000 Equity Securities . This represents 9.2% of the issued shares on hand (652,980,688) 12 months prior to the date of this Meeting.

- (ii) The relevant Shares and Placement Options B were issued to Vulcan Development Limited, an unrelated party of the Company. Vulcan Development Limited are sophisticated investors and were known to the Board of Directors.
- (iii) The 50,000,000 Shares issued under Listing Rule 7.1A are fully paid ordinary shares. The terms and conditions of the 10,000,000 Placement Options B issued under Listing Rule 7.1A are enclosed in Schedule 2 to this Notice. Placement Options B, once converted, will be converted into fully paid ordinary shares.
- (iv) the 50,000,000 Shares issued under Listing Rule 7.1A were issued at \$0.005 each. The Placement Options B were free-attaching options, and therefore nil consideration was paid for the Placement Options B, issued on the basis of 1 free attaching Placement Option B for every Share subscribed for under the placement detailed in Section 8 of this Notice.
- (v) The \$0.005 issue price of the 50,000,000 Shares issued under the Company's Listing Rule 7.1A capacity was higher than the closing price of the Shares on the date of issue (being 8 August 2023) of \$0.004. As a result, the Shares were not issued at a discount to the closing price on that date.
- (vi) A total of \$250,000 in capital was raised from the issue of the Shares and Placement Options B issued under Listing Rule 7.1A. The funds will be used for short-term working capital purposes such as used for exploration activities such as drilling, assaying and sampling at the Company's projects, and for general working capita. No funds have been spent so far.
