## **ENTITLEMENT OFFER – EXTENSION OF OFFER PERIOD**

Enterprise Metals Limited (ASX:ENT) (the **Company** or **Enterprise**) wishes to advise that it has resolved to extend the closing date of its ongoing non-renounceable entitlement offer announced on 5 June 2024.
