

Conversion of Options raises \$2.1m

Alto Metals Limited (ASX: AME) (Alto or Company) is pleased to announce that it has received \$2.1 million in cash and issued 30,000,000 fully paid new shares in the Company, through the conversion of 30,000,000 unlisted options, each having an issue price of \$0.07 cents per share.

The option conversion was strongly supported by existing shareholders and is a clear endorsement of the Company's strategy to focus on exploration. Alto is well funded with ~\$7.8 million in cash and a major drilling program underway at its 100% owned, 900km² Sandstone Gold Project, in Western Australia.


