# SHARE PURCHASE PLAN CLOSED

GWR Group Limited (ASX: GWR or the Company) is pleased to announce that the Company's Share Purchase Plan (SPP) closed on Wednesday 20<sup>th</sup> December 2017 with subscriptions for 4,258,813 ordinary shares.

The Company has instructed its share registry to allot and issue the SPP shares raising a total of \$362,000.

Following the issue of these shares the Company will have 252,494,410 shares on issue, which includes 2,677,699 shares that were granted to Directors in lieu of accrued fees.
