## **Mawson Evolution Continues with Assays and DHTEM**

- Semi-massive and massive sulphide assay results in RKDD043 return;
  - > 3.0m @ 1.04% Ni, 0.61% Cu, 0.09% Co from 181m
- Massive and semi-massive sulphide assay results in RKDD044 return;
  - > 1.7m @ 1.48% Ni, 1.12% Cu, 0.10% Co from 456.4m
- Downhole EM (DHTEM) from RKDD053 and RKDD044 provide target vectors

Legend Mining Limited (Legend) is pleased to report the assay results for diamond drillholes RKDD043/044/046 at the flagship Mawson nickel-copper-cobalt prospect within the Rockford project, Fraser Range, Western Australia (see Figure 4).

Comprehensive details are contained in the body of this report.

Legend Managing Director Mr Mark Wilson said: "The assays reported in this announcement are broadly in line with our expectations from visual observations of the core at site. The key point is the distance between massive sulphide occurrences and the broader mineralised intercepts give us the geological confidence of a fertile mineralised system of significant scale.

"Both the drilling and downhole EM results have continued the evolvement of our geological understanding of the Mawson intrusion. This is the objective of the current stage of our systematic ongoing exploration strategy at this prospect."



#### TECHNICAL DISCUSSION

Below is a technical summary of the assay results and DHTEM results received at the Mawson Ni-Cu-Co prospect since the ASX Announcement *1 June 2021*.




Figure 1: Diamond drillhole locations and defined chonolith model projected to surface over aeromagnetics

Assay results received from RKDD043/044/046 (see Figure 1) are in line with visual estimations. Multi-element data received as part of the assay suite will continue to provide critical data to existing datasets to further evolve the understanding of the chonolith driving the mineralisation at Mawson. This step-out drilling continues across Mawson at the time of writing, and the Company will update the market as results come to hand.

### **Assay Results**

Assay results have been received for diamond drillholes RKDD043/044/046 (see ASX Announcements 28 May 2021 and 1 June 2021).




Figure 2: Drill section 6,598,400mN looking north showing diamond drillhole RKDD043 and RKDD053 (Note – conductors strike N-S)

Diamond drillhole RKDD043 targeted the interpreted south-west extension of the eastern chonolith (see Figure 1, Figure 2, and Table 1). RKDD043 intersected a metasedimentary package from 52.3m to 79.7m before intersecting a variably mineralised gabbronorite with interleaved metasediments, anorthosite, and pegmatitic zones from 79.7m to 263.3m downhole. Mineralisation intersected included disseminated, blebby, heavy disseminated, brecciated, nettextured, semi-massive, and massive magmatic Ni-Cu sulphide. Semi-massive and net-textured sulphide was intercepted at 131.6m to 132.8m, 170.1m to 176.95m, and 178.5m to 180.85m with semi-massive and massive sulphide intercepted at 180.85m to 183.3m downhole. Textures of the sulphides across these zones indicate remobilisation of sulphide, suggesting the drillhole has not intersected the primary sulphide source, and assay results received confirm this observation (see Photo 2).






Figure 3: 6,599,200mN section looking north showing diamond drillholes RKDD044 and RKDD046.

RKDD044 was drilled off the north-eastern end of the EAGA, targeting the north-eastern interpreted extension of the eastern chonolith (see Figure 1, Figure 3, and Table 1). The drillhole intersected a weakly mineralised gabbronorite from 92m to 381m downhole before intersecting a meta-BIF and orthogneiss assemblage to 403.2m. The drillhole then entered an interpreted marginal early-stage recrystallised gabbronorite to 437.9m before intersecting a heavily mineralised gabbronorite to 476.75m. A zone of net-textured, semi-massive, and massive Ni-Cu sulphide was intersected from 453.2m to 458.1m. Detailed structural logging of RKDD044 suggests the zone of semi-massive and massive mineralisation is focused along pegmatoidal leuconorite veins with identifiable clasts of olivine gabbronorite, confirming the remobilised nature of the sulphide encountered (see Photo 3). Results are in line with visual estimations and in conjunction with structural observations, suggest the mineralisation encountered in RKDD044 is not the primary source.




Photo 3: Ni-Cu sulphide textures from RKDD044 (C from 457.4m and D from 458m)

Diamond drillhole RKDD046 returned assay results in line with visual assessment of mineralised intervals (see Figure 1, Figure 3, and Table 1). The disseminated zones intersected in mineralised intrusion between 300m and 344m suggest a fertile Ni-Cu system, resulting in upgrading of mineralisation when sulphide zones focus in a structural trap. The mineralised intrusion remains open to the west, east and north. Further expansion drilling is planned to follow the mineralised intrusion in the open directions.

#### **DHTEM**

DHTEM remains ongoing on completed diamond drillholes across Mawson. The latest DHTEM conductors are presented in Table 2.

DHTEM results from RKDD053 confirm the complex nature of the sulphide zone intersected in the drilling. DHTEM results suggest a limited size zone of sulphide lenses striking north-south. Coupled with geological and structural observations, this sulphide zone is mobile and is not the primary source/accumulation.

DHTEM results from RKDD044 support geological and structural observations that the sulphide zone is limited in size. The conductor orientations however support the structural vector, suggesting a prospective target area to the north/north-west of RKDD044.

DHTEM surveying and/or modelling is pending for RKDD045/046/048/049/051/052 at the time of writing. Large offhole features have been identified in data from RKDD045/047/048/052, with more modelling required to constrain features. These offhole features are proximal to the MLTEM D1 conductor, complicating interpretation due to the masking effects of D1.

- Diamond drilling continuing with two diamond rigs at Mawson systematically testing across priority areas.
- Ongoing DHTEM on all completed diamond drillholes to assist follow up drilling.
- Integration of DD, RC, aircore geochemical and geophysical datasets to evolve 3D emplacement model of Mawson, with new constrained gravity and magnetic inversions ongoing.




Figure 4: Rockford Project - Mawson Location
