FY24 Performance Rights granted under the Southern Cross Electrical Engineering Limited Senior Management Long Term Incentive Plan. The Plan was approved by shareholders at the 2021 AGM.

The key terms of the FY24 Performance Rights issued under the plan are:

to be performance tested over a three year period from 1 July 2023 to 30 June 2026.

*i* performance testing criteria are 50% against Absolute Total Shareholder Return (*i*TSR*i*) performance, and 50% against Earnings per Share (*i*EPS*i*) performance.

Both TSR and EPS KPIs are subject to a threshold and stretch target with 50% of the available rights vesting on achieving the stretch target, 100% vesting on achieving stretch and pro rata vesting in between.

TSR KPI has a threshold target of 8% compound annual returns over the performance period and a stretch target of 12%.

EPS KPI requires that EPS in 2026 has achieved a threshold target of 8% compound annual growth from the equivalent 2023 EPS and a stretch target of 12%.
