SUBSTANTIAL SHAREHOLDING REPORTING SYSTEM UPGRADE - RESTATEMENT OF PREVIOUSLY NOTIFIED RELEVANT INTERESTS

Sydney, 6 September 2013: The Commonwealth Bank of Australia Group (CBA) has upgraded its substantial shareholding disclosure system, effective 4 September 2013.

As a result of this upgrade, some of the relevant interests reported on previously lodged substantial shareholding notices (Forms 603 and 604) have changed, although do not require a new notice to be lodged under s.671 B (1) of the Corporations Act (2001). This is due to enhanced collation of data and improved recognition of the timing of transactions.

Any future substantial notice required under s.671B (1) of the Corporations Act (2001) will refer to the relevant interest details in Annexure A where necessary. Individual issuers will also be notified.

Holdings that have changed as at 4 September 2013 and require a Form 603 or 604 or 605 notice to be lodged, will be done as part of CBA's business as usual process.
