

AHI Signs Definitive Agreement with Netherland-based Inter-Psy B.V.

Highlights:

- **Definitive Agreements signed with INTER-PSY B.V.**
- **The integrated *HEALTHiCHECK* solution will be offered to the population of the Netherlands with full reimbursement via the Government funded Combined Lifestyle Intervention programs.**
- **The AHI technology will form an integral part of the GLI programs fight against Obesity and Chronic Disease identification and actionable care.**
- **Inter-Psy provide psychological, psychiatric, health and wellbeing services primarily to the Netherlands and European markets.**
- ***HEALTHiCHECK*, Inter-Psy's preventative health screen application is scheduled to go live in May 2022 in the Netherlands.**

Advanced Human Imaging Limited (ASX: AHI) (NASDAQ: AHI) (“AHI” or the “Company”) is pleased to inform its shareholders that further to the previous signing of a binding term sheet which was announced to ASX on 31 May 2021, the Company has concluded a definitive agreement with INTER-PSY B.V (Inter-Psy), a Netherlands-based mental health and preventative care company that has developed *HEALTHiCHECK*, a preventative health screening app for the Dutch and European markets.

HEALTHiCHECK is a preventive screening platform soon to be available in the Netherlands on both iOS and Android devices. Based on the evaluated results via the *HEALTHiCHECK* application, users receive professional advice on medically validated steps to be taken to improve health in a responsible manner.

HEALTHiCHECK works with an Information and Computer Technology “ICT” platform on which all data is collected securely and in accordance with EU privacy legislation allowing the results to be visually reported in real time. Where required *HEALTHiCHECK* also assists the medical process through referral and aftercare.

According to Inter-Psy, the *HEALTHiCHECK*, iOS and Android apps are scheduled to go live in May 2022 throughout the Netherlands: <https://www.healthicheck.nl/>

Inter-Psy plan to market the *HEALTHiCHECK* AHI integrated solution to the population of the Netherlands that are eligible for the Government funded GLI - gecombineerde leefstijlinterventie (combined lifestyle Intervention) program, which is a government funded behavioural change program designed for people who are overweight or obese, with the goal to achieve and maintain a healthier lifestyle through healthier food, eating habits, and exercise. In the Netherlands the Government pays organizations up to EUR800 per person that have a BMI over 30 that undertakes a 24-month GLI program. The AHI technology will be used as an obesity identification tool, to assist in the qualification and identification of the reimbursable constituency.

Upon the completion of the integration with AHI, Inter-Psy's intention is to offer the combined *HEALTHiCHECK* to the remaining countries within Europe, where the governments offer a similar program to the GLI initiative in the Netherlands.

Parties	Advanced Human Imaging Limited (“AHI”) INTER-PSY B.V (“Inter-Psy”)
Conditions Precedent	None
Agreement	Master Services Agreement (“MSA”) (Incorporating the Data Processing Agreement (“DPA”))
Description	The MSA is the main commercial agreement between the parties pursuant to which AHI agrees, inter alia, to grant a licence to Inter-Psy to use AHI’s licensed software development kits, and related intellectual property to integrate them into the <i>HEALTHiCHECK</i> platform/technology. In return, Inter-Psy has agreed to pay certain user fees, data storage fees, and support fees (“Fees”) to AHI.
Initial Term	This MSA will commence on 7 February 2022. 12 months, each term shall be renewed for consecutive further terms of 1 year each (unless terminated at least 30 days prior to expiry of the term).
User Target	Under the terms of the MSA, Inter-Psy will use its best endeavours to target 200,000 active users on the <i>HEALTHiCHECK</i> platform within the first 12 months. There are no penalties for not achieving this target.
Financial Impact	AHI does not expect any immediate material financial return as a result of entering into this agreement. AHI expects to start generating Fees from the commercial arrangement in the future, which cannot be forecast at this time.
Termination	The contracts may be terminated in the event that the counterparty is in material breach, suffers an insolvency event or sells its business or a majority of the shares in the counterparty (i.e. change in control). Either party may terminate the DPA for its convenience by written notice within 7 days of the expiry of the dispute resolution period, as defined in the MSA.
Governing Law	Australia
