Loan Notes

A\$3.062 mil Loan Notes. In October 2019, 35 loan notes of \$100,000 each totalling A\$3.5 million were issued (refer ASX announcement 14/10/19). Interest is payable quarterly at 6% per annum. The loan notes are unsecured. On 26 May 2021, 26 November 2021 and 26 May 2022, ADX repaid \$437,500 of the Loan Notes (total repaid \$1,312,500). Repayment of the balance of 2,187,500 is due on 26/11/2022.

Bank Loans - Austria

ADX Group (through its subsidiary, ADX VIE GmbH) has a loan facility guaranteed by the Austrian state and executed by Volksbank. EUR 120,000 collateral is held in an ADX VIE GmbH account with Volksbank. The facility consists of two parts:

- EUR 500,000, zero interest, payback started 30 June 2022 and ends 31 December 2024; and
- EUR 630,000, 1% interest, same payback terms as above.
