Peaks signs contract extension with Electric Brands Inc.

Estimated volume of at least 1.12 million cannabis beverage units per annum

Highlights:

- Under the agreement, EBI agrees to purchase cannabis-infused beverage products from Peak for distribution into the Canadian adult-use cannabis market
- EBI's range of cannabis beverages currently have annualised sales of approximately 1.12 million units per annum (excluding future growth)
- The extended contract term with EBI is 2.5 years
- The Canadian cannabis beverage product category is expected to be worth CAD\$134.4 million in 2023

10 August 2023: Althea Group Holdings Limited (ASX:AGH) ('AGH', or 'the Company'), a global leader in the manufacturing, sales and distribution of cannabis-based medicines and recreational cannabis products, is pleased to announce that its wholly owned subsidiary, Peak Processing Solutions ('Peak'), has signed a Contract Manufacturing Agreement ('CMA') extension with Electric Brands Inc. ('EBI') for a further 2.5 years.

Existing brand with significant market share

Under the CMA extension, EBI agrees to purchase from Peak, and Peak agrees to sell to EBI in accordance with an accepted Purchase Order, cannabis-infused beverage products, which have been manufactured by Peak.

EBI's existing suite of cannabis beverages includes Sweet Justice, its hallmark brand of Twisted Classics & Vibrant Sips.

The Sweet Justice range of cannabis-infused beverages are currently available in Ontario, British Columbia, Alberta and Saskatchewan, with expansion into Quebec, Manitoba and the Yukon, imminent. Sweet Justice is also available in the State of Michigan.

In the first six months of 2023, EBI shipped approximately 560,000 cannabis beverage units, and has established Sweet Justice as a leading independent brand with strong market share of the product category.

Based on these assumptions, EBI's existing range of cannabis beverages have annualised sales of approximately CAD\$5.4 million (excluding future growth).

The Canadian adult-use cannabis market is expected to be worth CAD\$6.4 billion in 2023¹, with the cannabis beverage product category representing 2.1%, or approximately CAD\$134.4 million, of the total market².
