## **Results of EGM**

29 November 2024: Althea Group Holdings Limited (ASX:AGH) ('AGH', or 'the Company'), a global leader in the manufacturing, sales and distribution of cannabis-based medicines and recreational cannabis products, advises that the resolutions put to the Extraordinary General Meeting (EGM) held on 29 November 2024 were determined by way of a poll. The results of the poll are summarised below and set out in the attached table.

The outcomes of the resolutions are as follows:

1. Resolution 1: Approval of issue of new options to placement participants: *Status*: Not carried

2. Resolution 2: Approval of issue of new options to lead manager: *Status:* Carried

3. Resolution 3: Approval of issue of new options to consultant: *Status:* Not carried

As a result of these outcomes, the Company will not proceed with the issuance of options to placement participants or to the consultant as outlined in Resolution 1 and Resolution 3 of the Notice of Meeting dated 1 November 2024. The Board respects the decisions of shareholders and will adjust its plans accordingly.

The Board reiterates its commitment to advancing the Company's strategy and exploring alternative means of achieving its capital and operational objectives. Further updates will be provided to the market as appropriate.
