### Distribution Reinvestment Plan (DRP) Reminder

The deadline to elect to participate in the June 2026 DRP has now passed.

2. Selecting issuer name “AGPL - AGP INVESTMENT MANAGEMENT LIMITED” and selecting BDCI as the fund,
3. Selecting ‘Payments & Tax’ then ‘Reinvestment Plans’,
4. Selecting ‘Create Instructions’ under BDCI in the ‘Action’ section, and
5. Selecting either ‘Full Participation’ or ‘Partial Participation’.

The DRP provides unitholders with a cost-effective means of maximising their investment in the Fund by reinvesting their distributions into additional units in the Fund<sup>1</sup>. Units issued under the DRP will be free of any brokerage, commission, stamp duty and other transaction costs and will rank equally with existing units from the date of issue.

The issue price for units allotted under the DRP will be the Fund’s net asset value per unit, ex-distribution, determined as at last day of the relevant distribution period. Any residual amounts will count towards future DRP allotments.
