Vesting of Performance Rights, Appendix 2A and Section 708A Notice

Vesting and Exercise of 2017/2018 Performance Rights

Chalice Gold Mines Limited ("Chalice" or "the Company", ASX: CHN | OTCQB: CGMLF) advises that, in accordance with the terms of the Company's Long Term Incentive Plan (Plan), 4,382,655 2017/2018 Performance Rights (Performance Rights) that were issued to Key Management Personnel and employees in 2017 have vested in full due to the achievement of the performance conditions measured over the three years ended 30 June 2020.

Upon vesting, 3,967,290 Performance Rights have been exercised into an equivalent number of fully paid ordinary shares (**Shares**) in accordance with the terms of the Plan. The Board has resolved to pay cash in lieu of the exercise of 415,365 Performance Rights, held by a non-Australian resident.

Attached is an Appendix 2A applying for the quotation of the Shares.

Section 708A Notice – Issue of Shares

In relation to the issue of 3,967,290 Shares following the exercise of Performance Rights (as referred to above and detailed in the accompanying Appendix 2A), the Company gives notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) ("Corporations Act")

The Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act. The Company relies on case 1 in section 708A(5) of the Corporations Act in respect of the issue of fully paid ordinary shares.

As at the date of this notice, the Company has complied with:

- (a) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
- (b) section 674 of the Corporations Act.

The Company confirms that, as at the date of this notice, there is no information that:

- (a) has been excluded from a continuous disclosure notice given to the ASX in accordance with the ASX Listing Rules; and
- (b) investors and their professional advisers would reasonably require for the purpose of making an informed assessment of:
 - (i) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; and
 - (ii) the rights and liabilities attaching to the Shares,
