# Entitlement Offer extended in response to postal delays

As announced on 5 October 2022, CZR Resources Ltd (ASX:CZR) (**Company**) is undertaking a 1 for 5 renounceable pro-rata entitlement offer of fully paid ordinary shares in CZR (**New Shares**) at an offer price of \$0.012 per New Share (**Entitlement Offer**).

The Company notes the current delays in mail delivery and that some shareholders have advised that they have not yet received their documentation. As a result, the Company wishes to advise that it has extended the Closing Date of the Entitlement Offer from 27 October 2022 to 3 November 2022.
