**CZR Resources Ltd's off-market takeover bid for all the shares of Zuleika Gold Limited –
Supplementary Bidder's Statement**

We act for CZR Resources Ltd ACN 112 866 869 (**CZR**) in relation to its off-market takeover bid under Chapter 6 of the *Corporations Act 2001* (**Corporations Act**) for all of the fully paid ordinary shares in the capital of Zuleika Gold Limited ACN 141 703 399 (ASX:ZAG) (**Zuleika**) (**Offer**) as detailed in the bidder's statement dated 20 August 2026.

In accordance with section 647(3)(b) of the Corporations Act, we enclose a first supplementary bidder's statement which contains:

- 1 pursuant to section 650D of the Corporations Act, a notice of variation of Offer, to extend the Offer period so that the Offer will remain open for acceptance until 5:00pm (AWST) on Friday, 6 November 2026 (unless further extended or withdrawn in accordance with the Corporations Act); and

This document is a supplementary bidder's statement dated September 2026 given under section 643 of the *Corporations Act 2001* (Cth) (**Corporations Act**) and incorporates notices given for the purpose of sections 630(2)(b) and 650D of the Corporations Act. This document is the first supplementary bidder's statement (**First Supplementary Bidder's Statement**) in connection with the off-market takeover offer by CZR Resources Ltd ACN 112 866 869 (**CZR** or the **Bidder**) to acquire all the ordinary shares in Zuleika Gold Limited ACN 141 703 399 (**Zuleika**) that it does not already own or control (**Takeover Bid**). This First Supplementary Bidder's Statement supplements and is to be read together with the bidder's statement dated 20 August 2026 (together, the **Bidder's Statement**). This document prevails in the event of any inconsistency with the Bidder's Statement. This First Supplementary Bidder's Statement was lodged with the Australian Securities and Investments Commission (**ASIC**) on 22 September 2026. Neither ASIC nor its officers take any responsibility for the contents of this First Supplementary Bidder's Statement. Unless the context otherwise requires, capitalised terms in this First Supplementary Bidder's Statement have the same meaning given to them in Section 13.1 of the Bidder's Statement. The rules of interpretation set out in Section 13.2 of the Bidder's Statement also apply to this First Supplementary Bidder's Statement, unless the context otherwise requires. Zuleika Shareholders are encouraged to read this document in its entirety. This is an important document and requires your immediate attention. If you are in doubt about how to deal with this document, you should contact your legal, financial, tax or other professional advisor immediately.

First Supplementary Bidder's Statement

1 Extension of Offer Period

The Bidder's Statement was lodged with ASIC on 20 August 2026.

The Bidder's Statement noted that the Offers and any contract resulting from acceptance of the Offers are subject to the Conditions.

The Offers were to remain open for the period commencing on the date of the Offers (24 August 2026) and ending at 5:00pm (AWST) on the later of:

- (a) 7 October 2026; or
- (b) any date to which the period of the Offer is extended in accordance with the Corporations Act.

In accordance with the terms of the Bid Implementation Deed, the Independent CZR Board has decided to extend the Offer Period by 30 days.

Accordingly, the Offer Period will now end at 5:00pm (AWST) on **Friday, 6 November 2026**, unless further extended or withdrawn in accordance with the Corporations Act.

2 Notice of variation to the Offer – Extension of Offer Period

The Bidder gives notice, for the purposes of section 650D of the Corporations Act, that it has, in accordance with section 650C of the Corporations Act, varied the Offer by:

- (a) extending the Offer Period so that the Offer will remain open for acceptance until 5:00pm (AWST) on Friday, 6 November 2026 (unless further extended or withdrawn in accordance with the Corporations Act); and
- (b) replacing references to "Wednesday, 7 October 2026" with "Friday, 6 November 2026" in all places in the Bidder's Statement where the closing date of the Offer is referred to (including the Acceptance Forms (as applicable)),

(**Variation Notice**).

A copy of the Variation Notice, as included in this First Supplementary Bidder's Statement, was lodged with ASIC on 22 September 2026. ASIC takes no responsibility for the contents of the Variation Notice or the contents of this First Supplementary Bidder's Statement.

3 New date for giving the notice on the status of the Conditions

The Bidder also hereby gives notice, for the purposes of section 630(2)(b) of the Corporations Act, that, as a result of the extension of the Offer Period as set out in this First Supplementary Bidder's Statement, the new date for giving the notice on the status of the Conditions is Friday, 30 October 2026 and accordingly:

- (a) the references to "Wednesday, 30 September 2026" in all places in the Bidder's Statement as the date for giving the notice on the status of Conditions is substituted with "Friday, 30 October 2026"; and
- (b) as at the date of this First Supplementary Bidder's Statement:
 - (i) the Offer and each contract resulting from its acceptance has not been freed from any of the Conditions set out in Section 12.8 of the Bidder's Statement; and
 - (ii) so far as CZR knows, none of the Conditions set out in Section 12.8 of the Bidder's Statement have been fulfilled and accordingly, the Offer and each contract resulting from its acceptance remains subject to the Conditions set out in Section 12.8 of the Bidder's Statement.

A copy of the notice for the new date for giving the notice of the status of the Conditions is included with this First Supplementary Bidder's Statement.
