## Biography – Dave Shatwell BSc (Hons), FAIG, FSEG

Dave Shatwell graduated with a BSC (Hons) from the University of Sydney in 1962. He worked initially for the NSW Geological Survey and later for the Bureau of Mineral Resources where he was involved with the discovery of the Woodcutters base metal deposit in the Northern Territory. He first worked in South America in 1968 for the Hochschild Group at the Arcata epithermal silver deposit in Peru.

In 1983 he joined Niugini Mining and was involved with early exploration of the Ladolam epithermal gold deposit and the discovery of the Lienitz orebody at Lihir, PNG. During the 1980's and 1990's he worked under contract for Niugini Mining and others in the SW Pacific, SE Asia and South America.

In 1996 while working for Climax Mining in Ecuador he identified targets that included the later discovery by Aurelian Resources in 2006 of the Fruta del Norte epithermal deposit recently developed by Lundin Gold.

Dave commenced work for Andean Resources as Chief Geologist in 2005, responsible for exploration at the Cerro Negro project in Santa Cruz, Argentina. Over a six year period, he led the technical team which made new high-grade vein discoveries at Eureka West, Mariana Norte, Mariana Central and Bajo Negro, as well as adding further resources at the Vein Zone and San Marcos deposits. These discoveries created enormous value for Andean Resources' shareholders, ultimately leading to the takeover of the company by Goldcorp in 2010 for US\$3.4 billion.

Since 2010, he has consulted to various groups.

Dave has been involved with two world-class epithermal gold discoveries (Ladolam and Cerro Negro) and has more than 20 years' cumulative exploration experience in South America.
