

## Further high-grade gold and silver demonstrate scale at Malvina

1 November 2021

E2 Metals (**E2** or **the Company**) is pleased to announce further high-grade gold and silver assay results from ongoing infill drilling at **Malvina**.

### **Highlights**

- Infill drilling at the new Malvina discovery has returned the highest-grade gold and silver mineralisation to date for the prospect.
- Drilling has confirmed continuity of the structure, with consistent gold and (particularly) highgrade silver mineralisation.
- High-grade mineralisation is now defined by 5 drill holes over a 250m strike with a weighted average grade of 2.2gpt Au and 708gpt Ag (12gpt AuEq) over 3.5m (downhole width).
- Gold and silver assay results include:

 Elsewhere, scout drilling along the Malvina structure has defined a new zone of high-grade mineralisation at Malvina Oeste.

Mineralisation at Malvina Oeste is open in all directions

Commenting on the results, Managing Director Todd Williams states: "These recent drill results at Malvina confirm high-grade mineralisation over a considerable strike with scope for both further extensions and repetitions. The very high silver values across consistent widths highlight the potential for both gold and silver discoveries within a world-class precious metal's province. The additional mineralised zone defined at Malvina Oeste, completely concealed by Tertiary basalt cover, reflects E2's ability to find mineralised veins without surface indicators. We remain confident that the broader Malvina sector represents a new vein corridor with tremendous exploration upside"

### Overview




Figure 1: Conserrat Project

E2 is pleased to report gold and silver assay results for the **Conserrat** gold and silver project (Figure 1) located in the Santa Cruz province of Argentina. **Conserrat** is host to a newly recognised and largely concealed epithermal vein field centered 25 kilometers along trend from AngloGold Ashanti's Cerro Vanguardia mine (historical and current reserves 8.9Moz Au, 137Moz Ag).




Figure 2: Malvina drill hole location plan

Gold and silver assay results have been received for 9 holes for 1045m from the **Malvina** and **Malvina Oeste** prospects (see Figure 2 & Table 1). Drill core samples were submitted to Alex Stewart in Perito Moreno, Santa Cruz and analysed for gold and silver via Fire Assay.

Significant gold and silver assay results are provided in Table 2.

### Results

#### Malvina

**Malvina** is host to a 'blind' high-grade silver and gold vein announced earlier this month (see ASX Announcement, 5 October 2021, Gold and silver assays confirm Malvina discovery)

Mineralisation is associated with meter-scale quartz veins emplaced within a homogenous ignimbrite sequence (white lithic tuff) with moderate oxidation and scarce malachite (copper oxides).




Figure 3: Malvina long section

To date, high-grade mineralisation (>20 gold equivalent grade by thickness) has been defined on four sections spaced 50m to 75m apart (Figure 2). The holes appear to define a sub-horizontal mineralised shoot with a possible **strike of 250m** and **vertical extent of 100m** (Figure 3).

The weighted average grade for all holes (n=5) within the mineralised shoot is **2.2gpt Au and 708gpt** Ag (12.5gpt AuEq) over an average downhole width of 3.5m.

Drilling to date shows a strong elevation control on mineralisation with the highest grades best developed from 50 vertical meters below the surface.

Core recoveries in mineralised zones are generally good but are as low as 57% for fractured ground within the vein structures, particularly in part of the hole CODD-162 intersection (see Table 2). The Company will twin the best mineralised diamond holes with Reverse Circulation (RC) to confirm the results.




Figure 4: Malvina cross section: hole CODD-162




Figure 5: Malvina Oeste cross section: hole CODD-163



#### Malvina Oeste

Scout drilling along the **Malvina** structure has defined a new high-grade mineralised zone at **Malvina Oeste**, located 500m to the northwest (Figures 2 & 5). So far only two drill-holes have tested the zone on sections spaced 100m apart, both of which intersected quartz veins. Results are only available for one drill hole and gave the following significant intercept:

CODD-163: **1m at 15gpt Au, 327gpt Ag (20 AuEq) from 65.2m** 

Mineralisation is associated with an intensely oxidised structure with local colloform-crustiform banding hosted within andesite. **Visible gold** was observed by hand lens in drill core samples.

Gold and silver assay results for hole CODD-172 located 100m to the northwest remain outstanding. The hole intercepted two oxidised veins confirming lateral continuity of the structure.

## **Next Steps**

Immediate drill priorities include:

- 1. Ongoing infill and delineation drilling at **Malvina** to define high-grade mineralisation on 50m spaced drill centers, and to a vertical depth of 150m below the surface.
- 2. Initial wide spaced infill and step-out drilling at **Malvina Oeste** to define the limits of high-grade mineralisation.
- 3. Ongoing scout drilling along the **Malvina Sur** corridor following up on hole CODD-154 which intercepted 5.75m at 1gpt Au, 18gpt Ag (1.3gpt AuEq) from 61.3m in the first scout hole.
