CLEANSING NOTICE AND APPENDIX 3B

The Directors of Equus Mining Limited ('Equus' or 'the Company') are pleased to advise that, further to the shareholders' approval received pursuant to ASX Listing Rule 7.3 to issue 37,500,000 ordinary shares at the Company's Annual General Meeting held on 28 November 2018, the Company will issue 28,812,500 new fully paid ordinary shares to Terrane Minerals SpA as consideration for the acquisition of the remaining 49% interest in the Electrum's exploration licences in the Los Domos projects. The shares to be issued as consideration for the Pedregoso I and VII and Honda 20 mining concessions will be issued in early 2019.




