Answer:

Having completed a significant exploration drill campaign in the March quarter and downsized activities to a smaller resource drilling program in the June quarter, the Company has reduced its exploration and administration expenditure. The effect of these measures will provide sufficient funds to continue operations for the next two quarters.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

It is the Company's intention to raise further capital during the quarter ending June or September 2020 to continue with its operations. The Company believes that the capital will be available due to the advanced status of the exploration and resource development programs at Cerro Bayo.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer:

The Company has reduced its exploration program in line with existing cash to continue trading beyond the September quarter. The effect of these measures will provide sufficient cash to October 2020.
