Answer: No. During the quarter that ended in December 2022, the Group announced the suspension of stockpile processing at the Cerro Bayo project. Although this measure has a delaying effect on the net cash flow from operating activities it is expected that the cash position improve in the coming quarters. The Group exploration activities have been reduced in line with available cash.
