

ASX Listing Rule 3.10.5A Disclosure

This notice is given by Geopacific Resources Limited ACN 003 208 393 ("Company") pursuant to ASX Listing Rule 3.10.5A in relation to an issue of 350,000,000 fully paid ordinary shares by the Company without disclosure to investors under Part 6D.2 of the Corporations Act.

The shares were issued by way of a placement to sophisticated and professional investors, pursuant to the Company's available capacity pursuant to Listing Rule 7.1 (210,931,722 shares) and Listing Rule 7.1A (139,068,278 shares).

Geopacific provides the following disclosures under ASX Listing Rule 3.10.5A:

(a) The dilutive effect of the Placement on existing shareholders was as follows:

- (b) The Company issued the shares as a Placement under Listing Rule 7.1A to sophisticated and professional investors as it was of the view that this was the most appropriate mechanism and lease dilutive way to raise the funds required to achieve its stated objectives.
- (c) The Company confirms that no underwriting agreements were entered into in respect of the Placement.
- (d) The fee payable by the Company in connection with the Placement comprised a cash fee of 5% (excluding GST) of the gross funds raised pursuant to the Placement.
