






Cross section 6880660mN +/-40m highlighting standout intersection in drillhole 21SSRC009 within the quartz dolerite.







# Mon Ami: Underground Potential




- New geological interpretation highlights high grade gold at intersection of vertical and inclined lodes → exploration vector

# East Laverton Nickel Project








