Great Southern Mining Limited (ASX:GSN) (**GSN** or the **Company**) is pleased to announce it has completed a placement of 31,846,669 fully paid ordinary shares (**Shares**) to sophisticated investors raising \$1,115,429 net of costs.

On 30 July 2018 the Company announced that it had received commitments to issue 34,000,000 shares. Having received commitments for the placement of 31,846,669 shares noted above, the placement was closed to allow the Company to focus on the upcoming timetable of activities including the exploration programs in Western Australia and North Queensland. As a result, less than the initial quoted number of shares was placed.
