### **CLEANSING NOTICE**

Further to the ASX announcement of 8 May 2020, Great Southern Mining Limited (GSN or the Company) provides the following information pursuant to Section 708A(5) of the *Corporations Act* 2001 (Cth) (the Act):

On 8 May 2020 the Company announced a capital raising to a number of professional and sophisticated investors. As part of this transaction, following approval at the General Meeting of Shareholders held 3 July 2020, the following quoted securities have been issued:

- 2,500,000 Listed Options (GSNOA) exerciseable at \$0.05 each on or before 4 September 2022; and
- 17,499,994 Listed Options (GSNOA) exerciseable at \$0.05 each on or before 4 September 2022.
