MULTIPLE TENEMENT APPLICATIONS TO EXPAND COX'S FIND GOLD PROJECT

- Applications made over a large tenement package immediately adjacent to GSN's 100% owned, high-grade Cox's Find Gold Project.
- Applications increase the land holding along known structural trends which host major gold deposits within the Duketon Greenstone Belt.
- The area has been subject to minimal exploration over the last decade and is regarded as highly prospective, within 20km of both the Garden Well and Rosemont mining operations.

Great Southern Mining Limited (ASX: GSN or the "Company") is pleased to announce it has lodged applications over 4 strategic and highly prospective tenements immediately adjacent to the 100% owned Cox's Find Gold Project (Cox's Find or the Project), 65km north of Laverton, Western Australia.

Following the acquisition of Cox's Find in August 2019, GSN focused on expanding the project tenure along strike in and around known prospective structural trends which host major gold deposits. to provide additional drill targets through the acquisition of new ground.




Figure 1: Plan view of the Cox's Find Project (light blue) and the applications lodged (dark blue) highlighting mineralised trends (red dashed lines) with GSWA geology background






Figure 2: Plan view of the Cox's Find Project (light blue) and the applications lodged (black outline) highlighting mineralised trends (red dashed lines) with GSWA magnetic data (TMI) background.

The area the subject of application E38/3518 (Figure 1 and 2) was identified as highly prospective for gold and would provide exceptional exploration potential. The substantial area, just over 50km² in total has a number of historical workings and provides GSN additional walkup drill targets. GSN has made applications over the following tenements:

Once granted, the tenement applications could increase the Cox's Find Project tenure 16-fold to a total of 54km² and include over 12km of access to the clearly identifiable mineralised trends that host both the Garden Well and Rosemont gold deposits (Figures 1 and 2).

GSN's Chief Operating Officer, Mark Major commented:

"These applications are a major step forward for the Company's gold strategy in the Duketon Belt. There are multimillion-ounce deposits such as Garden Well only 12km away with Rosemount a mere 20km from Cox's Find. With the potential for such a significant increase in land holding, underpinned by the high-grade Cox's Find Project, GSN is well placed and well-funded to unlock further potential in the Project through discoveries and potentially adding scale to the Project."
