# QUARTERLY ACTIVITIES REPORT FOR THE PERIOD ENDED 31 DECEMBER 2024

# **Key Points**

- Diamond drilling designed to provide geotechnical information to aid pit designs for the Gum Creek Feasibility Study (Study) is continuing and expected to be completed by the end of January 2025.
- Diamond drilling immediately down plunge of a previous 52m @ 5.9g/t Au from 91m<sup>1</sup> drill intercept at the Wedge Prospect has been completed with all assays pending.
- Approximately 10,000m of infill and extension RC drilling across all deposits included in the Study is set to commence early in February 2025. This drilling is aimed at upgrading the resource confidence across the Project's 2.14 million ounce gold resource, and testing the extension of high priority targets including the open down plunge position of a previous drill intercept of 24m @ 3.7g/t Au from 124m<sup>2</sup> at the Hawk Prospect.
- Work on the Gum Creek Gold Project Feasibility Study (Study) is continuing with a focus on geotechnical studies, comminution test work, further metallurgical sampling, environmental surveys and Project water management strategies.




Figure 1: Gum Creek Gold Project and surrounding gold resources and operating gold processing facilities.

Horizon Gold Limited (ASX: **HRN**) (**Horizon** or the **Company**) is focussed on progressing its exploration and development activities at the 100%-owned Gum Creek Gold Project (**Gum Creek** or the **Project**) located in the Mid-West Region of Western Australia (Figure 1). Gum Creek has historically produced more than 1 million ounces of gold and currently hosts a gold resource of **44.45Mt @ 1.50g/t Au for 2.14 million ounces**<sup>3</sup>. The Project currently covers 473km<sup>2</sup> of granted tenure over the highly prospective and underexplored Gum Creek greenstone belt, which contains 37 open pit and three underground gold mines.

During the quarter, nine diamond holes for 1,090m were completed across nine prospects including Wedge, Swift, Eagle, Kingfisher, Hawk, Heron South, Hyperno, Reliance and Think Big. The program is providing important geotechnical information to aid in the design of open pits for the ongoing Gum Creek Feasibility Study. The diamond drill program is expected to be completed by the end of January with geotechnical logging, rock strength testing and gold analysis to be completed early in March 2025. The drilling has also tested a high priority target immediately along strike and down plunge of a previous



broad, high grade gold intercept of **52m @ 5.9g/t Au from 91m to EOH** including **13m @ 16.7g/t Au** from 123m (WERC002) at the Wedge Prospect (see Figure 2). All assay results are pending.




Figure 3: Hawk Prospect long section showing gold intercept gram x metre pierce points, historic open pit, A\$2,800/oz optimised pit shell, block model and proposed diamond and RC drilling mineralisation pierce points.

Following completion of the diamond drilling, approximately 10,000m of infill and extension RC drilling will commence across all deposits included in the Gum Creek Feasibility Study. This drill program will enhance the geological and resource confidence level across the Project's 2.14 million ounce gold resource and test high priority targets including the open down plunge position of a previous drill intercept of **24m @ 3.7g/t Au** from 124m including **11m @ 7.6g/t Au** from 125m (HKRC001) at the Hawk Prospect (see Figure 3). RC drilling will be completed at 15 existing resource areas and at Eagles Peak South where there is potential for a maiden resource to be defined. The RC program drilling will begin early in February 2025 and is expected to be completed within 6 to 8 weeks of commencement.

Work on the Gum Creek Gold Project Feasibility Study is continuing with a focus on geotechnical studies, comminution test work, further metallurgical sampling, environmental survey evaluations and planning and Project water management strategies. The Company believes the Gum Creek Gold Project can be a robust, viable stand-alone mining operation and the work completed during the quarter has significantly advanced the Study.

The Project has significant upside including excellent potential to extend the 10-year Gum Creek Scoping Study mine life through resource expansion drilling and underground mining. Underground mining options and economic evaluations on the Swan/Swift, Kingfisher, Omega and Wilsons deposits are yet to be completed, and additional drilling at the 12 open pittable resource areas not included in the Scoping Study will likely increase the resource size of these deposits and elevate them to an economically viable status, further enhancing the positive financial outcomes of the Gum Creek Gold Project.



# Corporate

## Sale of Alto Metals Limited Shares

In November 2024 the Company sold its entire shareholding in Alto Metals Limited (ASX:AME) totalling 60,764,746 shares for total consideration of \$5.16 million following acquisition of the shares in July 2023 for \$3.17 million.

## Funding

Following the sale of Alto Metals Limited shares the Company repaid in full the short-term loan facility from Zeta Resources Limited (Horizon's major shareholder) of \$1,200,000 plus interest in November 2024.

## Additional ASX Listing Rule Disclosures

As required by ASX Listing Rule 5.3, the Company advises it spent \$637,000 on exploration and evaluation activities during the quarter. The expenditure is predominantly related to costs associated with diamond drilling, further economic evaluation of the Gum Creek Gold Project, and ongoing tenement rents and rates. There was no mining development or production activities conducted during the quarter.

The total amount paid to directors of the entity and their related parties and associates (Section 6 of Appendix 5B) was \$102,000, encompassing the Executive Director's salary, Non-Executive Directors' fees and associated superannuation, and \$14,000 relating to geological drafting, administration services and other services.

As at 31 December 2024, Horizon had a cash at hand balance of \$3,635,000.
