EcoPro Innovation increases Lithium Offtake Volume from Rhyolite Ridge

Highlights:

- EcoPro Group, a major cathode supplier for global battery manufacturers, has agreed to increase its offtake volume with ioneer to 7,000 tpa, the maximum amount under the June 2021 binding agreement.
- The increase is in response to EcoPro Group's plans to significantly increase cathode material production.
- The total contracted volume represents 34% of ioneer's annual lithium carbonate output for the first three years of production.

Wednesday, 16 February 2022 – ioneer Ltd ("ioneer" or the "Company") (ASX: INR), an emerging lithium-boron supplier, today announced that EcoPro Innovation Co Ltd ("EcoPro"), part of the EcoPro Group of Companies, has exercised an additional 5,000 tpa of lithium carbonate offtake as detailed in the original binding lithium offtake supply agreement¹ ("Agreement") announced June 30, 2021. EcoPro Innovation has confirmed an increase to the initial 2,000 tpa annual volume in the Agreement to 7,000 tpa.

ioneer will supply EcoPro Innovation with lithium carbonate from its Rhyolite Ridge Lithium-Boron Project ("Rhyolite Ridge") in Nevada. The Agreement remains conditional on ioneer taking a Final Investment Decision (FID) on the Rhyolite Ridge Project.

The increased total offtake represents approximately 34% of ioneer's annual lithium carbonate production from Rhyolite Ridge in the first three years of operation.

EcoPro Innovation expects to convert ioneer's lithium carbonate into high purity lithium hydroxide at its recently complete integrated cathode plant in Korea.

ioneer Managing Director, Bernard Rowe, said:

"We are delighted that EcoPro Innovation has increased their lithium carbonate offtake commitment from Rhyolite Ridge. As a major cathode supplier for global battery manufacturers EcoPro Group is an ideal partner for ioneer. We are encouraged to support the US car manufacturing industry and look forward to continuing to work with EcoPro Group in these endeavours."

EcoPro Innovation President Anthony Kim, said:

"We have always had great relationship with ioneer and we are pleased to strengthen our partnership with ioneer by increasing lithium carbonate offtake volume. We, EcoPro as a group, have intentions to expand overseas to support environmental policies such as carbon neutralization and net zero emission. With ioneer as a partner, we look forward to contributing to the electrification of transportation in the USA."

ioneer is expected to produce an annual average of approximately 20,600 tonnes of lithium carbonate, or approximately 22,000 tonnes of lithium hydroxide, along with approximately 174,400 tonnes of boric acid per year over the 26-year mine life². The dual production of lithium and boric acid allows ioneer to not only produce lithium in the US, but to do so at the very bottom of the global cost curve. ioneer anticipates commencing production in late 2024.
