Dear Option Holder

YOUR OPTIONS TO ACQUIRE IRON ROAD LIMITED SHARES AT \$0.20 PER SHARE EXPIRE ON 30 SEPTEMBER 2010

We are writing to you as a registered holder of 30 September 2010 options in Iron Road Limited to remind you that the options will expire at 5:00pm (WST) on Thursday, 30 September 2010.

Your option holding may be exercised in whole or in part by payment of \$0.20 for each option by no later than 5.00pm (WST) 30 September 2010. If payment is not received by 5:00pm (WST) on 30 September 2010 the options will lapse and all rights under the options will cease at that time.

Some of the courses of action available to you as a holder of these soon to expire options are:

- a) Exercise the options on or before 30 September 2010.
- b) Sell your options. Quotation of the options will cease at the close of trading on 23 September 2010.
- c) Do nothing (ie, allow your options to expire). If you do not exercise or sell your options they will expire on 30 September 2010 and your right to subscribe for ordinary shares in Iron Road Limited at \$0.20 per share will lapse.
