

## Central Eyre Iron Project 2010 Drilling Programme Update

**Fortnight to 03 December 2010**

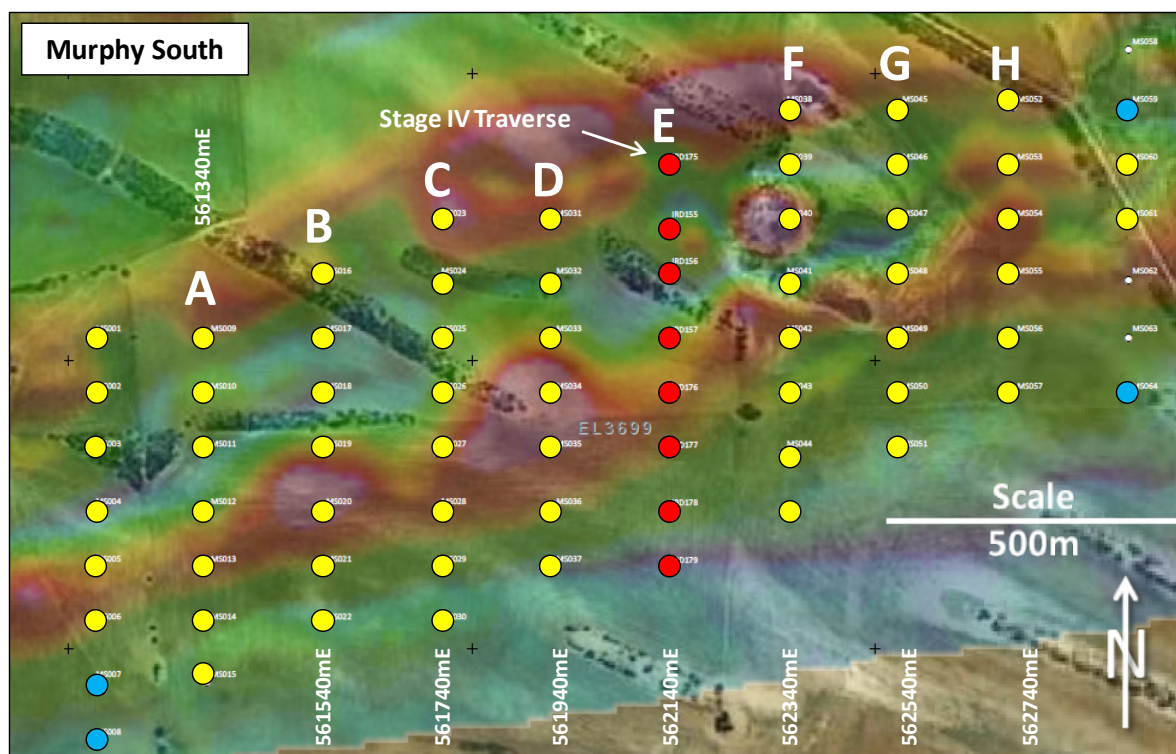
**Iron Road Limited** (Iron Road, ASX: IRD) is pleased to advise that Stage V drilling at the Central Eyre Iron Project (CEIP) continues to proceed to plan.

### CEIP Summary

- Additional drill rig mobilised at Murphy South bringing the total to four diamond drill rigs on double shift.
- On track for completion of Stage V drilling by mid-December 2010.
- Preparations underway to ensure Murphy South JORC compliant mineral resource estimate report is released late January 2011.

### Progress to date

The exploration target for Murphy South, across the 10 traverses designed for the Stage V drilling programme, is 400-800Mt magnetite gneiss\*.

The cross-sections presented below and marked A, B, C, D, E, F, G and H, have been completed at Murphy South and are awaiting assays. Geology and surface area calculations do not include the entire near surface oxide component (drilled by RC rig). Sections 561140mE and 562940mE are in progress. The geology intersected in all traverses thus far is consistent with expectations. Note that drill hole traces are design and are yet to be corrected for deviation.

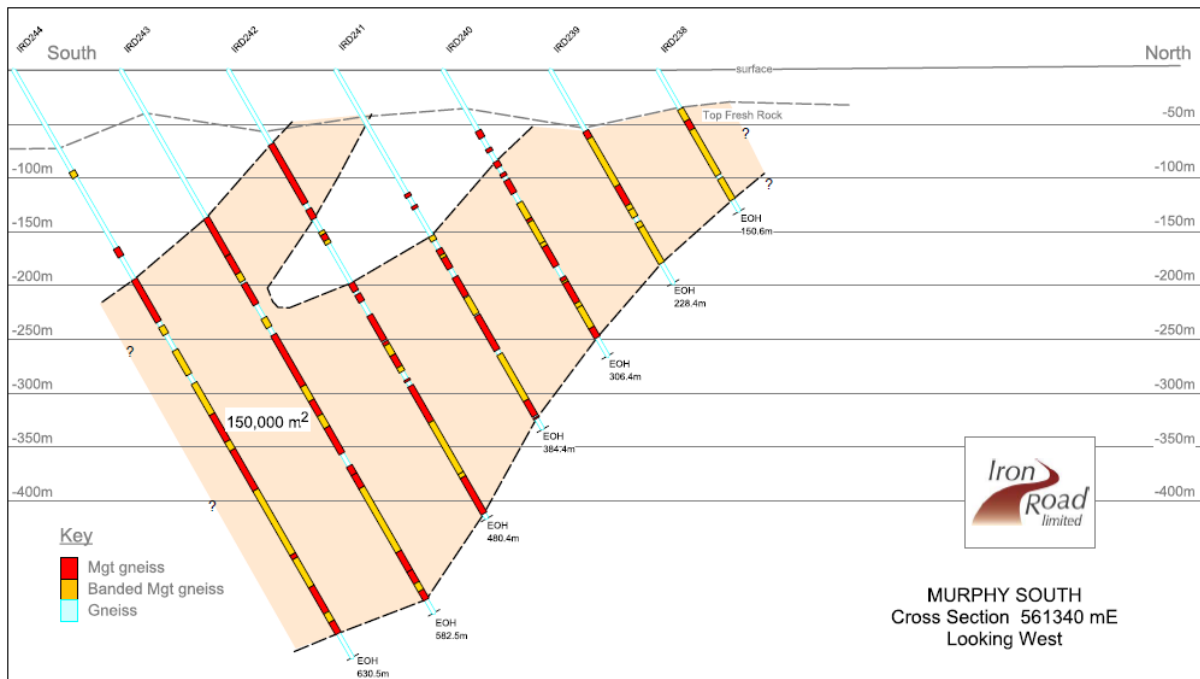

(A) Section 561340mE

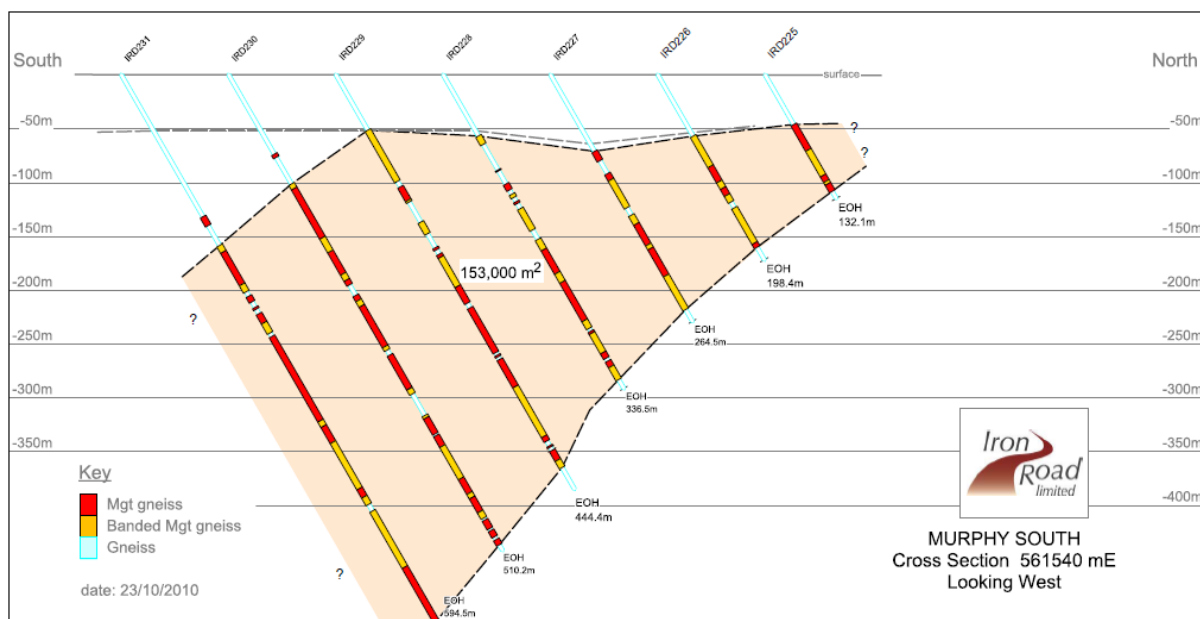

(C) Section 561740mE

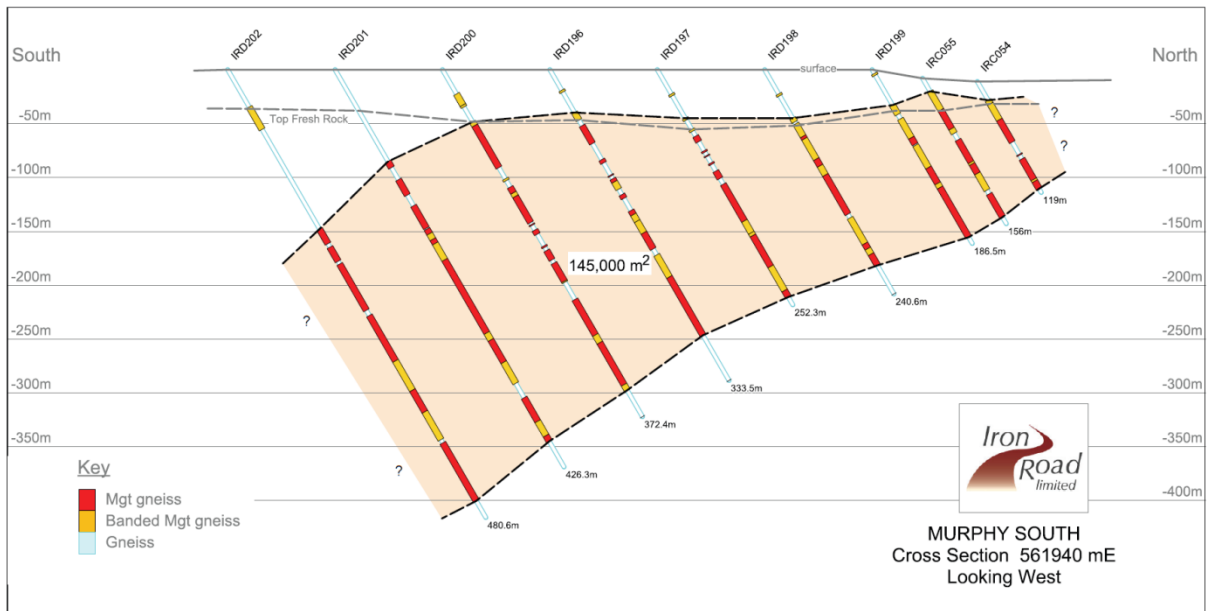

(D) Section 561940mE

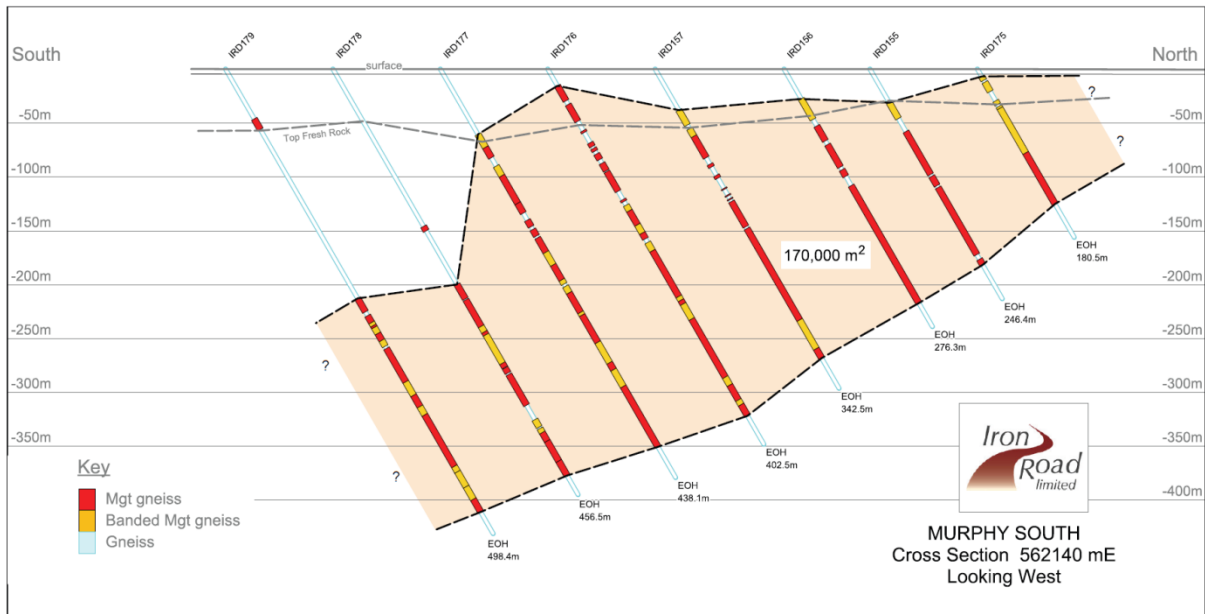

(E) Section 562140mE (Stage IV Discovery Section)

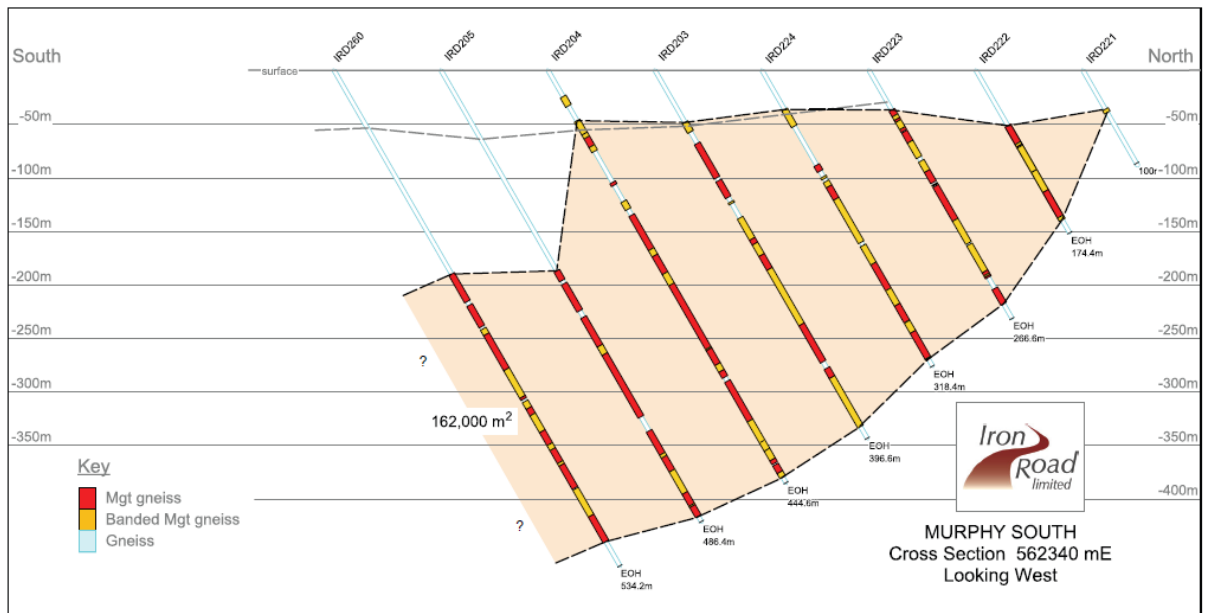

(F) Section 562340mE

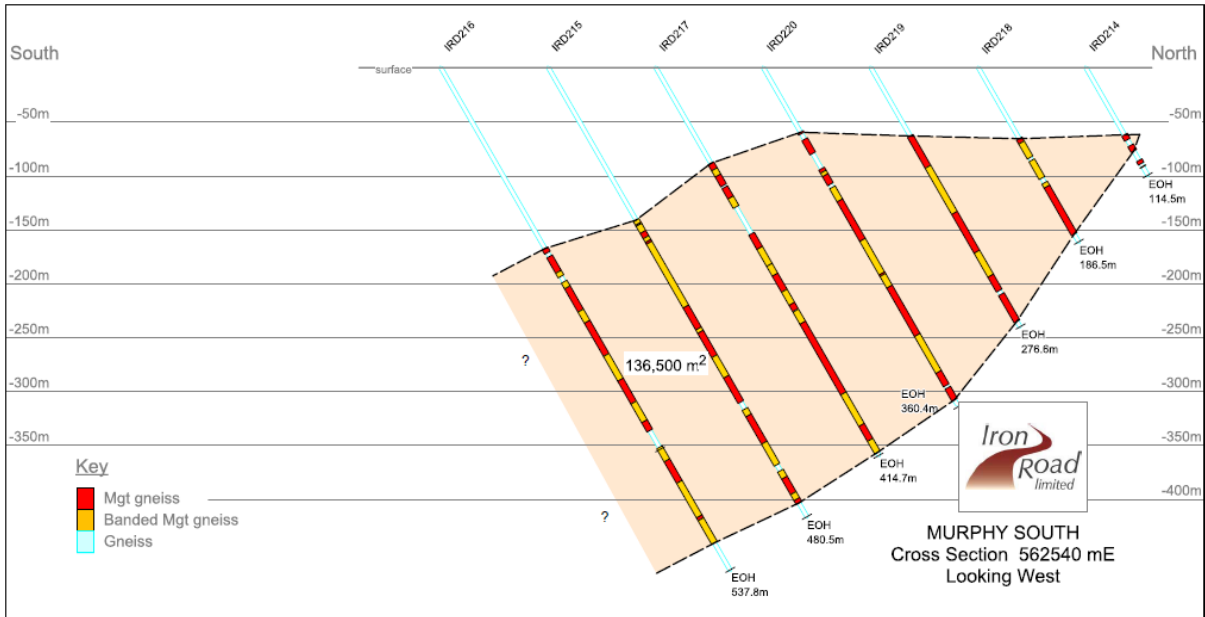

(G) Section 562540mE

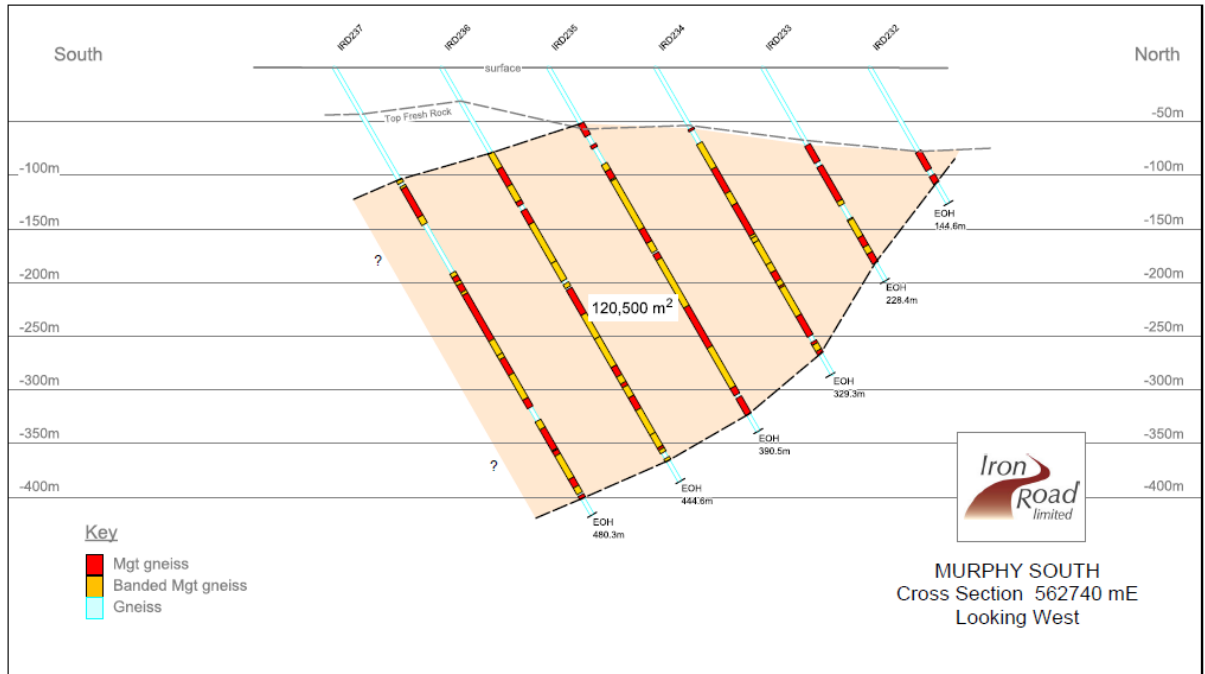

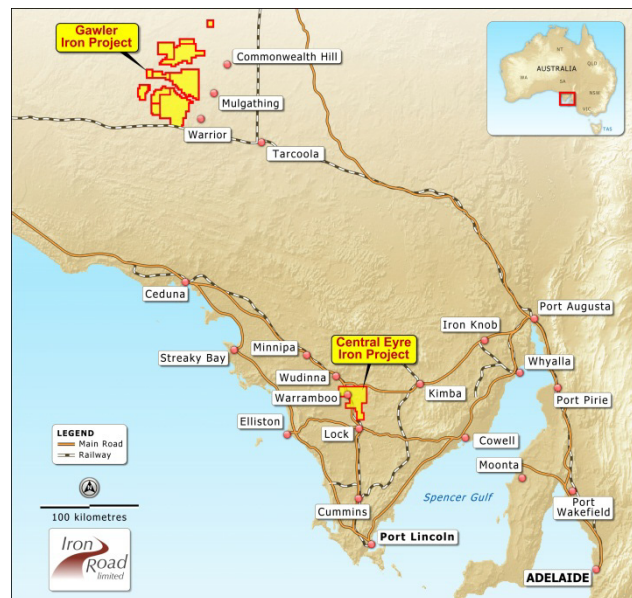
