Lanthanein Resources Limited (Lanthanein or the Company) advises that all resolutions put to shareholders at today's Annual General Meeting were carried on a poll.

Lanthanein provides the information required by section 251AA of the Corporations Act 2001 (Cth) in respect of each resolution considered by shareholders at today's Annual General Meeting in the attached summary overleaf.

The total number of proxy votes exercisable by proxies validly appointed was 526,085,009 shares in the Company.

As more than 75% of the votes cast on Resolution 1 were in favour of the adoption of the 2024 Remuneration report, a "second strike" for the purpose of the Corporations Act was avoided, and Resolution 2, the conditional spill resolution, was withdrawn.
