FIRST HOLE COLLARED AT HILL 335 TARGET, CAMEROON

Legend Mining Limited (Legend) is pleased to announce that diamond drilling recommenced

on 27 January 2011 at its Ngovayang Iron Ore Project in Cameroon, West Africa. This

drilling marks the resumption of the proposed 5,000m man portable rig programme, which

was suspended on 30 September 2010 due to monsoonal rains.

Legend Managing Director Mr Mark Wilson said: "This event culminates several months of

intensive logistical preparations. The Cameroon exploration team have done an outstanding

job to get back to drilling and we look forward to the information flow from this work in due

course."

The proposed programme is targeting a combination of aeromagnetic and topographic highs

associated with +50% Fe rockchip sample results. Seven priority target areas will be tested

during this 5,000m phase of drilling - Hill 335, Hill 419, Melombo, Melombo West, Melombo




Figure 1: Ngovayang Project Drill Targets over Aeromagnetic Image (Analytical Signal of Total Magnetic Intensity)

East, Bibondi and Logmangan, see Figure 1.

Drilling is currently underway at Hill 335, where geological mapping has identified a shallow

dipping sequence of magnetite rich metasediments at least 50m thick. This sequence

extends south of the Nyong River at Hill 419, were a strong aeromagnetic feature coincides

with a 1km long prominent ridge.

Following the drilling of these two prospects, the drilling rig will move south to the Melombo,

Melombo West and Melombo East targets, where the magnetic features are interpreted to

represent linear near vertical units of itabirite or metamorphic banding associated with

magnetite-bearing gneiss.

Results of the drilling will be released to the market as they become available.
