Canbelego Joint Venture with Straits Resources

Helix has completed its earn-in and secured a 70% equity interest in the Canbelego Joint Venture with Straits Resources Limited. Straits have notified Helix (the manager) that they will contribute to the joint venture at their 30% equity interest.

The Canbelego Joint Venture in the Cobar Region of NSW includes the Canbelego Mine Prospect (1.5mt @ 1.2%Cu inferred resource*) and the recently drilled Caballero Prospect, which lies 2.5km south of the Canbelego Mine Prospect on the same geological trend. Both JV partners have agreed to Phase 1 of a Forward Work Program.

Helix recently completed a drilling program at both the Canbelego Mine and Caballero prospects. At Canbelego the RC and diamond drilling intersected stringer and breccia veined copper sulphides (drilling assays still pending). At Caballero the single RC hole **returned 12m @ 0.9% Cu incl. 4m @ 1.4% Cu and 4m @ 1.1% Cu** within the oxidized zone above an EM conductor. This intersection occurred within a broader zone of 68m @ 0.4% Cu (single metre re-split drilling assays are still pending).

The JV partners have agreed to drill a second deeper RC hole at Caballero targeting sulphide mineralisation below the initial intersection, which is coincident with a high copper in soils anomaly (up to 0.3% Cu) and a 500m long fixed loop EM conductor. The hole is expected to be drilled in the week commencing 16th September 2013.

The remainder of the agreed Forward Work Program will include additional fixed loop EM and down-hole EM surveys in the recently drilled holes, infill augur soil geochemistry and further drilling.
