# **Diamond and Aircore Drilling Recommences at Mawson**

Legend Mining Limited (Legend) is pleased to announce that diamond and aircore drilling has commenced over the weekend at the Mawson prospect within the Rockford Project in the Fraser Range (see Figure 3).

### **Diamond Drill Programme**




Figure 1: Proposed Mawson Diamond Drillhole Locations on Aeromagnetics

Earthworks have been completed for six new diamond drillholes (A-F; see Figure 1). Hole A is designed to target the 6,000-8,000S offhole conductor (see ASX announcement 23 January 2020) and will be the first hole drilled. Holes B and C are collared 40m east and west of hole RKDD007 and will provide further structural information on this section. The remaining holes, D, E and F are collared to drill under the geochemical footprint as shown and have been designed to better understand the geology of the Mawson prospect. Further holes are anticipated as results from this programme come to hand.

## **Aircore Drill Programme**




Figure 2: Greater Mawson Areas for Proposed Infill Aircore Drilling on Aeromagnetics

A 130 hole infill aircore drill programme has also commenced over selected areas at the Greater Mawson prospect (see Figure 2). The holes are on a nominal 200m x 200m grid and have been designed to give a better understanding of the geochemistry, rock type and depth of cover in areas which have already produced modelled conductors from Legend's innovative moving loop electromagnetic surveys and/or anomalous geochemistry from previous aircore programmes. Further infill holes will be drilled as required. Ultimately the results of this programme will be a valuable tool for prioritising and ranking future diamond drill programmes.




Figure 3: Rockford Project - Mawson Location
