Corporate Governance Statement

Introduction

This Corporate Governance Statement (Statement) is current as at 27 September 2024 and has been approved by the Board of Directors of Medallion Metals Limited (Medallion or the Company) on that date.

The Board is responsible for the overall corporate governance of the Company. The Board guides and monitors the business and affairs of the Company on behalf of the shareholders by whom they are elected and to whom they are accountable. This Statement outlines the key corporate governance policies and procedures adopted by the Board of the Company on 23 October 2020.

In establishing its corporate governance framework and the policies and procedures that comprise the Company's Corporate Governance Plan (the **Plan**), the Company has referred to the Australian Securities Exchange (**ASX**) Corporate Governance Council's 4th Edition (February 2020) of the Corporate Governance Principles and Recommendations (the **Recommendations**).

To the extent applicable, commensurate with the Company's size and nature, the Company has adopted the Recommendations, unless stated otherwise.

The Company will review on an annual basis all of its corporate governance policies and procedures under the Plan to ensure they are appropriate for the Company's current stage of development.
