## NSW Lachlan Cu-Au Project Update

### **Highlights**

- Systematic exploration program continuing at the Lachlan Cu-Au Project in NSW
- New 3km long base metal anomaly associated with north-east trending fault structures identified by geochemical sampling at Myamley in Central Region Project Area
- RC drilling work programs to follow up new and existing anomalies currently being assessed by the NSW Department of Energy and Resources
- Work program to be submitted for follow-up RC and diamond drilling program at Blind Calf, targeting recently identified DHEM conductors and areas beneath the known high-grade lodes
- Detailed structural mapping program over the Blind Calf area commenced, with initial data review underway in preparation for field activities toward the end of July
- Auger drilling continuing to test Blind Calf and Mineral Hill Corridor extensions within the Southern Region Project Area at the Boona Project




Figure 2: EL8615 - Myamley Project - Auger geochemistry

Talisman Mining Ltd (ASX: **TLM**, **Talisman**) is pleased to advise that the on-going Stage 1 regional exploration on the wider Lachlan Cu-Au Project (**Lachlan Project**) is continuing to deliver high quality geochemical targets that justify Stage 2 RC drill testing. Results from the second phase of systematic auger geochemical sampling, which targeted the Myamley Project, have identified a large base metal anomaly associated with north-east trending fault structures identified by TLM during preliminary reconnaissance prospecting (*Figure 2*).

The identified anomaly extends across two sampled areas for over 3 kilometres of strike along an interpreted fault structure. The area contains a number of small historic shafts and abandoned mine workings that are associated with highly weathered gossanous host rocks (*Figure 2*). A second infill geochemical sampling program will be undertaken to better define the size of the identified anomaly which currently remains open along strike. Subject to the outcomes of the sampling program, a first drill program may be undertaken at Myamley during the December quarter 2018.

#### **Blind Calf Other Work**

A detailed structural mapping exercise has commenced with initial compilation and review of existing and historic drilling data progressing and field mapping expected to commence toward the end of July/early August. The scope of the study will include a 3D interpretation of the identified Blind Calf lodes, local and regional structures and further targeting within the NW-SE trending Blind Calf corridor.

#### **Systematic Exploration Strategy**

Talisman is undertaking a staged systematic exploration approach across the Lachlan Project area which is designed to build a pipeline of exploration targets through rigorous and sound exploration techniques.

This approach has three integrated stages of work:

#### Stage 1: Reconnaissance Exploration

Stage 1 work includes the identification of geological target areas through the interpretation of base layer regional data sets including geophysical data, geological mapping, the collation and interpretation of historic data, and on-ground prospecting by Talisman's geological team.

Following this work, systematic geochemical data is collected across areas identified as conceptual targets and may include auger drilling or conventional soil sampling, depending on target area ground conditions. More localised geophysical surveys including surface EM, gravity or IP surveys may also be undertaken at this stage.

The Lachlan Project covers over 3,175km² of the highly prospective Cambellego-Mineral Hill Rift sequence. As currently proposed, Stage 1 reconnaissance exploration across the Lachlan Project area is anticipated to continue for the next 12 – 18 months in parallel with the drilling of more advanced targets.

The first Stage 1 geochemical sampling programs completed to date by Talisman on the Central Lachlan Project Area have identified two separate geochemical anomalies that will be advanced to Stage 2. It is anticipated that more such anomalies will be generated over the next 6 – 12 months as Talisman's geochemical sampling crew continue to collect high-quality data.




Figure 3: Lachlan Project – Southern Region Area, showing on-going Stage 1 auger sampling areas, planned Stage 3 RC drilling areas and historic rock-chip results<sup>1</sup>

This Stage 1 work is ongoing, with the auger drill rig currently on-site testing the south-eastern extensions of the Mineral Hill and Blind Calf mineralisation corridors (*Figure 3*).

#### Stage 2: Target Development

Following on from the initial geochemical data collection and interpretation, anomalous areas are assessed based on geology, regolith and geomorphology criteria. Anomalies that are assessed as favourable are advanced though to Stage 2 testing. This second stage work may include deeper air-core and/or RC drilling depending on a number of geological factors including depth of cover and weathering.

The NSW Department of Energy and Resources (**DER**) has defined a clear process for the application and granting of work programs. This process involves several steps, including specific on-ground data collection prior to the submission of an application, and statutory notice periods

following DER approval of the submitted work program. From the date of submission of a work program with the DER, on-ground Stage 2 activity generally commences six weeks later.

Talisman currently has two work programs for Stage 2 drilling lodged with the DER including RC drilling to test the historic Cumbine (IP and geochemical) anomaly and the Cu-Pb-Zn geochemical anomaly identified in Talisman's first auger sampling program (*refer to TLM ASX release dated 17 May 2018*).

Given the lag in timing from target identification through to on-ground activity, it is prudent for Talisman to have a series of work programs at various stages progressing through the DER in parallel. Accordingly, in addition to the two work programs currently being assessed by the DER, Talisman has a further two work programs in draft which are anticipated to be submitted for DER assessment in the coming weeks.

#### Stage 3: Refined Targeting

The final stage of Talisman's exploration strategy is refined targeting. This work includes follow-up RC and diamond drilling of Stage 2 targets, DHEM surveys and detailed structural logging and analysis of drill core.




Figure 4: Blind Calf long section showing historic drilling, and recent high-grade Intersections from Talisman drilling.

Talisman is currently progressing one Stage 3 work program, which will include both RC and diamond drilling to follow-up the high-grade copper mineralisation identified at the Blind Calf Prospect identified in the recently completed Stage 2 RC drilling campaign (*Figure 4 and Appendix 2*). This Stage 3 exploration at Blind Calf is anticipated to be on-going with new work programs submitted following successful completion of the previous drilling and interpretation of results.

This work is again subject to the estimated six-week approval period between work program submission and the commencement of on-ground activity. While Talisman currently has one prospect area in the Stage 3 category of exploration, in the fullness of time it is anticipated that many more target areas will be elevated to advanced exploration status.

#### **About Talisman Mining**

Talisman Mining Limited (ASX:TLM) is an Australian mineral development and exploration company. The Company's aim is to maximise shareholder value through exploration, discovery and development of complementary opportunities in base and precious metals.

Talisman holds a 30% interest in the Springfield Joint Venture with Sandfire Resources NL (70% and JV manager). Springfield is located in a proven VMS province in Western Australia's Bryah Basin and contains multiple prospective corridors and active exploration activities. Springfield hosts the high-grade Monty copper-gold deposit which is located 10 kilometres from Sandfire's DeGrussa operations. Monty is one of the highest-grade copper-gold discoveries made globally in recent decades and a Feasibility Study on its development was completed in March 2017. The Feasibility Study highlighted the strong technical and financial viability of Monty. The Monty deposit is currently under development and Talisman has secured project debt financing for 100% of its share of pre-production capital costs.

Talisman also holds 100% of the Sinclair Nickel Project located in the world-class Agnew-Wiluna greenstone belt in WA's north-eastern Goldfields. The Sinclair nickel deposit, developed and commissioned in 2008 and operated successfully before being placed on care and maintenance in August 2013, produced approximately 38,500 tonnes of nickel at an average life-of-mine head grade of 2.44% nickel. Sinclair has extensive infrastructure and includes a substantial 290km² tenement package covering more than 80km of strike in prospective ultramafic contact within a 35km radius of existing processing plant and infrastructure.

Talisman has also secured tenements in the Cobar/Mineral Hill region in Central NSW through the grant of its own Exploration Licenses and through separate farm-in agreements. The Cobar/Mineral Hill region is a richly mineralised district that hosts several base and precious metal mines including the CSA, Tritton, and Hera/ Nymagee mines. This region contains highly prospective geology that has produced many long-life, high-grade mineral discoveries. Talisman has identified a number of areas within its Lachlan Cu-Au Project tenements that show evidence of base and precious metals endowment which have had very little modern systematic exploration completed to date. Talisman believes there is significant potential for the discovery of substantial base metals and gold mineralisation within this land package.



# Appendix 1 Lachlan Copper- Gold Project tenure



- i. As previously announced to the ASX<sup>2</sup>, Haverford Holdings Ltd (**Haverford**), a 100% owned subsidiary of Talisman, has entered into a Farm-In Agreement (**Farm-in**) with Bacchus Resources Pty Ltd (**Bacchus**) over certain Lachlan Cu-Au Project tenements. In accordance with the terms of the Farm-in:
  - Haverford can earn up to a 80% interest in the Bacchus Tenements (EL8547, EL8638, EL8657, EL8658 and EL8680) by sole funding \$2.3M of on-ground exploration expenditure over four years; and
  - Should Haverford earn an interest in the Bacchus Tenements, Bacchus is entitled to receive a 20% interest in the Haverford Tenements (EL8615, EL8659 and EL8677). Should Haverford not earn an interest in the Bacchus Tenements, Bacchus may elect to take a 20% interest in the Haverford Tenements.
- ii. As previously announced to the ASX<sup>3</sup>, Haverford has entered into a Farm-In Agreement (Farm-in) with Peel Mining Limited (ASX:PEX) over PEX's Mt Walton (EL8414) and Michelago (EL8451) Projects (collectively the Peel Tenements). In accordance with the terms of the Farm-in, Haverford can earn up to a 75% interest in the Peel Tenements by sole funding \$0.7M of on-ground exploration expenditure over five years.


