



2017 PROJECT ACTIVITY MCARTHUR RIVER PROJECT

- 600 line km airborne electro-magnetic (AEM) survey completed in Q3
- Several strong geophysical anomalies outlined from interpretation of SkyTEM AEM survey
 - Known anomalism in Wollogorang Formation well defined in geophysics
 - Anomalies in overlying Mallapunyah Formation
- Mapping and sampling completed in Q3
 - Up to 44.5% Cu in rock chip samples (and 56.7g/t Ag and 2350ppm Bi)
 - Dolomite-hosted copper mineralisation (to 6.3% Cu, 990ppm Mo)
- Targets identified both up and down sequence
- Additional tenure pegged






2017 PROJECT ACTIVITY SOLDIERS CREEK PROJECT

- Recently granted tenement prospective for pegmatite-hosted lithium (Li-Sn-Ta)
- Three historic tin tantalum mining areas on tenure
- Mapping and sampling defined a 800x500m area at Collia with abundant sheeted pegmatites in granite
- ▶ Up to 2235 ppm Li₂O and 632ppm Cs in rock samples
- Up to 75% tin (SnO₂) and 1400ppm tantalum in pan concentrate samples
- Significant rare earth assays (to 1.22% Ce) from concentrates at Collia










