**Correction of Appendix 3X for Mr Robert Dobson Millner**

TPG Telecom Limited (ASX:TPG) (TPG) wishes to notify ASX that, due to an administrative oversight, the Appendix 3X lodged for Mr Robert Millner on 14 July 2020 contained an error in respect of the number of TPG securities in which Mr Millner has an interest.

As you will note, the Appendix 3X was lodged on the implementation of the merger between ASX:TPM and TPG. As a result of the merger, shares that Mr Millner previously owned in ASX:TPM were exchanged for the same number of shares in ASX:TPG.

Mr Millner's disclosures to the ASX for ASX:TPM were correct. The oversight in the Appendix 3X lodged for ASX:TPG arose as a result of a transposition error caused by referring to the incorrect 3Y for ASX:TPM when the implementation documents for the transaction were prepared.

Accordingly, we now enclose a corrected Appendix 3X for lodgement which accurately shows Mr Millner's interest in TPG.

TPG takes compliance with the ASX listing rules seriously and each Director is informed of their obligations, including ASX disclosure requirements, upon their appointment.
