QUARTERLY ACTIVITIES & CASH FLOW REPORT DECEMBER 2023

Highlights

East Canyon Uranium Vanadium Project

- Fieldwork (mapping and sampling) completed across various East Canyon prospects
- Significantly over 30 occurrences of uranium minerals identified at surface across East Canyon claims along a consistent RL (elevation)
- Fieldwork completed at Loya Ray identified 5 clusters of uranium minerals observed along 2.4km strike length uranium anomaly
- Fieldwork completed at previously unknown and untested uranium anomaly prospect Big Sally identified uranium soil anomalism
- Additional previously unknown prospects with uranium minerals identified along similar elevation to known historical occurrences
- Laboratory results from rock chip samples collected from completed fieldwork at East Canyon expected imminently
- Planning underway for northern hemisphere spring-summer-autumn field season including sedimentary facies mapping and drill hole planning

South Pass Lithium Project

- Secured highly prospective hard rock lithium project in Wyoming
- Direct staking completed via Uvre, securing a first mover advantage in the area and representing a low cost entry
- Maiden field exploration program completed which consisted of mapping and sampling various outcropping pegmatites
- Laboratory results from rock chip and soil samples expected imminently



Uvre Limited (**Uvre** or **Company**) (**ASX: UVA**) is pleased to provide a summary of its Quarterly Activities and Cash Flow Report for the quarter ended 31 December 2023.

East Canyon Uranium Vanadium Project

The East Canyon Project (100% ownership) is strategically located in south-eastern Utah, USA, which is in close proximity to established mining operations and infrastructure within the extended Uravan Belt, a well-known uranium and vanadium district.







The Uravan Mineral Belt and surrounding Salt Wash ore producing districts of the Colorado Plateau, which hosts the Claims, has been an important source of uranium and vanadium in the US for more than 100 years, with historic production of more than 85 million pounds of uranium at an average grade of more than $0.13\%~U_3O_8$ and more than 440 million pounds of vanadium at an average grade of $1.25\%~V_2O_5$.

The district hosts several significant uranium-vanadium operations and the only fully licensed and operating conventional uranium-vanadium mill in the US (Energy Fuels' White Mesa Mill) is located 50km from the East Canyon Project along major highway 191.

Operational Overview - East Canyon Uranium Vanadium Project

During the quarter the Company completed some key fieldwork which consisted of mapping and sampling several prospects across the East Canyon claims and investigating two significant uranium anomalies identified via airborne radiometric survey, Loya Ray and Big Sally.




Figure 1. East Canyon project showing all prospects and uranium mineral locations identified during the mapping program.

Over thirty (30) mapped occurrences of uranium minerals were identified at a consistent elevation range within the East Canyon Project area. This observation provides a general favourable horizon to search for uranium mineralisation across the entire East Canyon Project area in the Salt Wash Member which is a considerably large search space. Figure 1 provides the locations in which uranium minerals (note map/key showing carnotite, uraninite, coffinite locations) were observed as well as the additional prospects previously unknown to the Company and only identified during the recent mapping campaign. (These newly identified prospects have been named Sue Mac, Balmia, None Such West, None Such East and Bonanza West as well as the additional clusters identified at Loya Ray along the 2.4km strike length.

Loya Ray Uranium Prospect - East Canyon




Figure 2. Loya Ray Prospect showing mapped uranium mineral locations relative to the U^2 /Th imagery depicting the 2.4km trend.

The Loya Ray 2.4km strike length uranium anomaly was also identified from the recently completed radiometric survey with anomalism defined by the ratio of U²/Th (figure 2). This anomaly was confirmed with uranium-vanadium minerals at surface observed in five (5) clusters over the strike length and some small scale historical open pit mining was also observed at the 'Loya Ray' mine (figure 2 and picture 1). This is highly encouraging given the large strike of the U²/Th anomalism which was confirmed with uranium-vanadium mineralogy in the recent mapping program. The five clusters at Loya Ray are referred Loya Ray, Loya Ray West, Loya Ray Central 1, Loya Ray Central 2 and Loya Ray East (figure 2). The surface mineralisation at Loya Ray now requires detailed facies mapping prior to drill testing to understand the most favourable stratigraphic distribution of mineralisation along the 2.4km strike length and to ascertain if the northeast trend is channel influenced. The mineralisation style understanding is critical to ensure future drill hole testing investment is used to maximum effect by placing the holes in the best possible locations to intersect uranium-vanadium mineralisation. Further sampling of the small pit area is also required to understand if ore was left in the walls, floor or along strike of the shallow mined pit. Rock chip and crumbly clay profile samples were sent to a certified laboratory for analysis of uranium, vanadium and rare earth elements and once received further confirmation sampling will be conducted at Loya Ray.

Big Sally Uranium Prospect - East Canyon

The Big Sally prospect was identified as a prominent uranium anomaly² defined by a ratio of U²/Th delineated from the recently flown radiometric survey. This prospect was previously unknown prior to the airborne survey being flown and had not been subject to any prior exploration work by the Company. Initial fieldwork at Big Sally has identified the prospect is anomalous for uranium within the soil profile and further facies mapping and sampling is required to understand the distribution of uranium within the profile to target drill testing. Several soil and rock samples were taken within this area and have been sent to a certified laboratory for uranium, vanadium and rare earth analysis with results expected imminently. This prospect sits above the targeted elevation range within the Saltwash Member and the uranium-vanadium mineralisation may be influenced by faulting. Further detailed facies mapping will assist to understand the best locations for drill targeting.




Figure 3: 5km East-West Trend image of the processed radiometric data showing the U2/Th ratio imagery which has been stretched to identify the highest tenor areas of interest in which to focus exploration for uranium. The newly identified anomaly Big Sally in the western portion of the trend was previously unknown and is untested.

5km East-West Trend - East Canyon

In the northern East Canyon area, the 5km East West trend³ also reported consistent uranium-vanadium minerals associated with the Saltwash member elevation range as observed in the western and southern East Canyon project areas including Loya Ray. Big Sally in the west of the 5km East West trend sits at a higher elevation and this may be influenced by fault displacement. Further detailed facies mapping and more sampling is required prior to drill testing to ensure the holes are drilled in the most prospective locations. The identification of so many outcropping uranium minerals over a large search area of five (5) kilometres has

highlighted the uranium potential outside the previously drilled prospects Bonanza and None Such.




Figure 4. East Canyon project showing 5km East-West Trend to the east of the 5km East-West Trend, the Stateline prospect returned high scintillometer readings with carnotite and uraninite or coffinite observed (picture 2) within crumbly clay stone close to a sandstone contact.

The number and geographical spread of uranium minerals over the East Canyon project, comprising carnotite and either uraninite or coffinite, confirms uranium and vanadium exists throughout the project area and the mineralisation appears constrained to an elevation within the flat lying easterly dipping Saltwash Member stratigraphy. These observations provide further encouragement to understand which facies within the Saltwash Member are most favourable for uranium-vanadium and rare earth mineralisation, and if mineralisation is deposited within channels at the Loya Ray prospect. Uranium mineralisation was observed within the soil profile at Big Sally and associated with claystone and sandstone elsewhere on the project.

All samples taken during the fieldwork were submitted to a certified laboratory and analysis for uranium, vanadium and rare earth elements is pending with results expected imminently.

South Pass Lithium Project

The South Pass Lithium Project (100% ownership) is strategically located, highly prospective hard rock lithium project in Wyoming, USA which was secured via direct staking by the Company during the quarter. The South Pass Lithium Project comprises of 206 unpatented mining lode claims covering an area of 4,258 acres and is located near the Wind River Range, Fremont County, Wyoming, USA.

The South Pass Lithium Project is a large, early stage and highly prospective exploration project with favourable geological characteristics. These include outcropping pegmatites and dykes that occur in large swarms which have the potential to contain lithium bearing Lithium Caesium Tantalum (LCT) pegmatites. This potential is based on historical lithium mineral reports and lithium detected in historical regional multi element chemical sampling.

Given the favourable geology, recent exploration activities and discoveries of lithium in the Wyoming/South Dakota regions by other companies (Chariot Corporation ASX.CC9 and Iris Metals ASX.IR1)⁴ gives the Company reason to believe Wyoming could be an emerging US lithium province.




Figure 5. Location of South Pass Project in emerging Wyoming-South Dakota lithium province.




Figure 6. South Pass Lithium Project geology map showing spread of Archean granites and pegmatites.

Uvre believes the South Pass Lithium Project has large scale potential due to the extensive exposures of outcropping pegmatites visible from satellite imagery, including in Google earth and confirmed during field reconnaissance. Pegmatites were observed up to several hundred metres long in the vicinity of nearby faults and the South Pass greenstone belt. Similar pegmatites in the district have been found to be enriched in columbite, tantalite, microline, tourmaline, beryl and garnet, with accessory minerals including **lithium bearing lepidolite and spodumene**, which illustrates the potential for pegmatites within the South Pass Lithium Project to be fertile for lithium mineralisation.

There has been no or little prior recorded systematic exploration for LCT pegmatites in the South Pass area and scant prior work was limited to regional mapping and sampling, mainly focussed on gold occurrences.

Prior reported spodumene and lepidolite occurrence was noted by gold geologists from the northern area of the South Pass Lithium Project where small scale prior pegmatite mining has taken place, provides Uvre with encouragement that lithium minerals occur on the mining claims.

The presence of numerous pegmatite outcrops alongside dykes and granites suggests that the deeper crust may harbor a mixture of rocks derived from the mantle. This mixture appears to be mature enough in its development to host lithium and comprise LCT pegmatites.

Reconnaissance exploration sampling program was completed at the Project during the quarter with baseline geochemical rock chip sampling conducted over circa half of the swarms of untested pegmatites. Rock chip and soil samples were dispatched for laboratory analysis for Lithium (Li) and Rare Earths Elements (REE) with results anticipated imminently.







New Project Opportunities

The Company assessed, reviewed and evaluated several strategic and complementary asset opportunities during the guarter.

As outlined in the IPO prospectus and Company announcements since, together with its exploration strategy, the Company intends to continue to seek out and assess potential exploration, acquisition, joint venture, or other strategic opportunities that are complementary to existing assets and create further value for the Company's shareholders.

Corporate

Material outflow during the quarter comprised ~\$147,000 in acquisition costs to secure the mining claims that form the new South Pass Lithium Project in Wyoming. The Company also used funds for geological consulting, database management and tenement management during the quarter across both projects.

Uvre held cash reserves of ~\$2.895M as at 31 December 2023.

In accordance with ASX Listing Rule 5.3.2, the Company advises that no mining development or production activities were conducted during the quarter.

Related Party Transactions

In accordance with ASX Listing Rules 4.7C.3, payments to related parties of the entity and their associates outlined in the Company's Appendix 5B for the quarter relate to Directors fees of \$80,000 and professional and consulting fees of \$24,000 paid to Grange Consulting for company secretarial and financial management services.
