Federal Court Approval of Vault Scheme of Arrangement

Damstra Holdings Limited (**Damstra** or the **Company**, ASX:DTC), an Australian-based provider of integrated workplace management solutions, is pleased to note that the Federal Court of Australia (**Court**) has today made orders approving the scheme of arrangement (**Scheme**) under which Damstra will acquire all of the issued capital in Vault Intelligence Limited (**Vault**).

As Vault has already released to the ASX ('Federal Court Approve Scheme'), the Court orders are expected to be lodged with the Australian Securities and Investments Commission (**ASIC**) tomorrow, Thursday 8 October 2020, at which time the Scheme will become legally effective.
