


### WORLD CLASS NICKEL PROVINCE

- Western Australia's Yilgarn Craton one of the world's major nickel provinces
- World-class examples of komatiite-hosted Ni-Cu-PGE deposits Kambalda (35Mt @ 3.1% Ni), Perseverance (50Mt @ 2.3% Ni) and Mt Keith (643.7Mt @ 0.58% Ni)

### **MULGA TANK PROJECT**

- Frontier exploration play for major komatiite-hosted Ni-Cu-PGE deposits under cover
- Strategically assembled 395km<sup>2</sup> position on the under-explored Minigwal Greenstone Belt
- Mulga Tank Ultramafic Complex (WMG 100%) comparable scale (29km²) to the Kambalda Dome camp
- Tenure under-explored to date significant potential for exploration upside




### POTENTIAL MAJOR KOMATIITE NICKEL SYSTEM UNDER COVER

- Minigwal Greenstone Belt and Mulga Tank Ultramafic Complex under explored due to ~60m sand cover
- Limited diamond drilling has penetrated ultramafic system nearly all holes show komatiite/dunite hosted Ni-Cu-PGE sulphide mineralisation
- Large meso-adcumulate dunite body (~14km²) with interpreted komatiite channel flows extending NW over >12km




# SYSTEMATIC EXPLORATION APPROACH



### **VECTORING TOWARDS NICKEL MINERALISATION**

- Building a robust exploration model for the discovery of nickel sulphide deposits
- Combined geophysical, geological and geochemical vectoring
- Historical datasets (magnetics, EM, HeliSAM, DHEM, pXRF, soil partial leach)
- WMG recent high resolution ground gravity and high powered MLEM surveys
- Only 12 historical drill holes deeper than 150m
- WMG Phase 1 diamond drilling April to July 2022 10 holes for 3,990m
- Phase 2 commencing end November 2022
- Exploration team lead by WA nickel expert Dr Ben Grguric





# VISIBLE NICKEL SULPHIDES IN SIX OUT OF TEN HOLES

- Phase 1 drilling program April to July 2022 10 holes for 3,990m
- Tested a range of geological and geophysical targets




### REMOBILISED NICKEL SULPHIDE VEINING

- Holes MTD012 and MTD013 tested up dip of major W Conductor EM anomaly
- Multiple zones of remobilised visible nickel sulphide veins
- Hole MTD012: **0.5m at 1.49% Ni, 0.04% Cu and 0.04% Co** from 385.8m
- Holes MTD013: 1.6m at 0.83% Ni and 0.30g/t Pt+Pd from 304m inc. 0.4m at 1.34% Ni, 0.04% Co and 0.55g/t Pt+Pd from 304.4m
  - **0.4m at 1.29% Ni and 0.43g/t Pt+Pd** from 153.6m
- Initial appraisal of sulphide veins suggests likely physically remobilised from a massive sulphide source
- Type 1 Perseverance-style target
- Follow-up MTD022 at depth






# **MULGA TANK DUNITE**



## **DISSEMINATED SULPHIDES OVER > 300M**

- Hole MTD020 intersected >300m of disseminated magmatic sulphides within high MgO adcumulate dunite
- Sulphides coalesce into interstitial blebs towards base of unit
- Clear indication of major magmatic sulphide mineral system
- Potential for large-scale Type 2 Mt Keith-style mineralisation
- Extensive untested area of dunite intrusion could fit multiple Mt Keith orebodies!







# **CHASING MAJOR DEPOSITS**



### **EVIDENCE OF LARGE-SCALE WORKING SYSTEM**

- Successful EIS award of \$220,000 towards two deep diamond holes
- Aim to capture complete cross-section of the dunite intrusion
- Meso-adcumulate dunite body of comparable size/scale to Perseverance and Mt Keith
- Unlock knowledge of the intrusion and test major targets


