Under the terms of these options to be granted by Westfield Holdings Limited to Westfield Management Limited, Westfield Management Limited is required to pay Westfield Holdings Limited the exercise price of that option. The number of Westfield Shares to be issued by Westfield Holdings Limited will equal the number of Westfield Trust Units to be issued on exercise of the Deutsche Options. These arrangements are set out in clause 2.4(a) of the Implementation Deed (see Annexure B of the Explanatory Memorandum dated 25 May 2004).

The exercise price payable by Westfield Management Limited to Westfield Holdings Limited is 33.8% of the exercise price of a Deutsche Option for each Deutsche Option exercised.
