**WESTFIELD GROUP (ASX:WDC)
NUMBER OF STAPLED SECURITIES ISSUED PURSUANT TO WESTFIELD GROUP STAPLED
SECURITIES PURCHASE PLAN**

We advise that 5,971,444 ordinary stapled securities (**New Securities**) will be issued on 8 April 2009 pursuant to the Westfield Group Stapled Securities Purchase Plan (**SPP**). The New Securities have an aggregate issue price of approximately \$59.9 million. An Appendix 3B is attached.

The New Securities will rank for distributions from 1 January 2009. As such, the new securities will be entitled to full distribution for the period ending 30 June 2009. In all respects, the New Securities will rank equally with all other ordinary stapled securities on issue and trade under the code "WDC".
