**WESTFIELD GROUP (ASX: WDC) - REQUEST FOR TRADING HALT**

Westfield Group (WDC), comprising Westfield Trust, Westfield America Trust and Westfield Holdings Limited requests a trading halt for a total of two trading days in respect of its shares (code:WDC) pursuant to Listing Rule 17.1, commencing today.

For the purposes of Listing Rule 17.1, WDC provides the following information:

- (a) a trading halt is necessary to allow WDC to complete the institutional component of the Westfield securityholder offer announced by WDC to the ASX yesterday;
- (b) WDC requests that the trading halt continue until open of trading on Monday, 8 November 2010, unless WDC requests that the trading halt be lifted before that time; and
- (c) WDC is not aware of any reasons why the trading halt should not be granted, or of any other information available at this stage that is relevant to the trading halt.
