

# AHI Signs Binding Term Sheet with Inter-Psy to integrate CompleteScan into Health i Check


## **Highlights:**

- Binding term sheet signed with INTER-PSY B.V.
- Inter-Psy provide psychological, psychiatric, health and wellbeing services primarily to the Netherlands and European markets.
- Health i Check, Inter-Psy's preventative health screen iOS and Android app is scheduled to go live in June 2021 in the Netherlands.
- AHI's technology will be integrated into the Health i Check platform for an October 2021 release.
- The integrated Health i Check solution will be offered to the population of the Netherlands under the Government funded Combined Lifestyle Intervention programs.

Advanced Human Imaging Limited (ASX: AHI) ("AHI" or the "Company") is pleased to inform its shareholders that the company has signed a binding term sheet with INTER-PSY B.V (Inter-Psy), a Netherlands based mental health and addiction care company that has developed Health i Check, a preventative health screening app for the Dutch and European markets.

Health i Check is a preventive screening instrument platform soon to be available in the Netherlands on both iOS and Android devices. Based on the results of Health i Check, users receive professional advice on medical steps to be taken and how to improve health in a responsible manner. Health i Check works with an ICT platform on which all data is collected securely and in accordance with privacy legislation and on which the results are visually reported in real time. Where required Health i Check also supports the medical process by means of referral and aftercare.

The Health I Check iOS and Android applications are scheduled to go live in June 2021 in the Netherlands: https://www.healthicheck.nl/ with the AHI integration planned to go live in October 2021.

Inter-Psy plan to market the Health i Check AHI integrated solution to the population of the Netherlands that are eligible for the Government funded GLI - gecombineerde leefstijlinterventie (combined lifestyle Intervention) program, which is a government funded behavioural change program designed for people who are overweight or obese, with the goal to achieve and maintain a healthier lifestyle through healthier food, eating habits, and exercise. In the Netherlands, the Government pays organizations up to EUR800 per person that have a BMI over 30 that undertake a 24-month GLI program.

Upon the completion of the integration with AHI, Inter-Psy's intention is to offer the combined Health i Check to the remaining countries within Europe, where the governments offer a similar program to the GLI initiative in the Netherlands.

The Company has developed and patented a proprietary technology which enables its users to privately check, track, and accurately assess their dimensions, solely using a smartphone. AHI refers to this physical measurement and analysis tool as "BodyScan." AHI is globalizing its technology in order to assist individuals, communities and populations live healthier lives, worldwide.

AHI's patented technology allows individuals, via an automated system, take a series of images of themselves using a smartphone which delivers accurate and repeatable measurements across the individual's entire body. These measurements allow the individual to understand his/her dimensions and the physical changes which they are undergoing through diet, exercise and lifestyle. Further, the images that AHI captures also provide the individual with an understanding of their health risk related to certain chronic diseases (including obesity and related diseases such as diabetes). AHI uses global standards set by the World Health Organization (WHO), and the International Diabetes Federation (IDF) when assessing and deriving this information feedback loop.

The Company has recently advanced its technology to run these complex mathematical algorithms directly on the user's smartphone, rather than limiting that computation to the Cloud. The result is a solution that runs on-device and does not sacrifice speed, security or privacy. Images and private information never leave the users personal device, ensuring security and privacy standards are met across global regions and requirements.

This unrivalled process allows us to produce exceptional results and simplify the output of useful, reliable, digital measurements and remove the human error otherwise present in traditional methods.
