Arafura completes despatch of Retail Offer Booklet

On 10 August 2018 Arafura Resources Limited (ASX: ARU) (**Arafura, the Company**) announced an accelerated non-renounceable 1 for 4 pro-rata entitlement offer of new ordinary Arafura shares (**Entitlement Offer**).
