### CLEANSING NOTICE AND APPENDIX 2A

Auteco Minerals Ltd (AUT.ASX) ('Auteco' or 'the Company') has issued 225,000,000 fully paid ordinary shares at an issue price of \$0.135 per share pursuant to the share placement announced to the ASX on 6 July 2020.
