SECONDARY TRADING NOTICE PURSUANT TO SECTION 708A(5) OF THE CORPORATIONS ACT 2001 ("Act")

On 23 July 2020, Cazaly Resources Limited ("the Company") issued a total of 200,000 fully paid ordinary shares ('Shares') in the Company on the conversion of options.
