## Commencement of RC Drilling Program at Mt Venn Gold Project

### **Highlights:**

- A 30 hole 3000m, Reverse Circulation (RC) drilling program has commenced at the Mt Venn Gold Project, located 30km from Gold Road Resources' 6Moz, Gruyere gold mine in Western Australia.
- The drilling program targets the undrilled, high-grade Chapman's Reward gold prospect where rock chip sampling has returned values up to 201g/t Au.
- Assay results from the RC drilling program are expected in February 2021.




Figure 1: Mt Venn Project – Location and Regional Geology

Further to its update on the 24<sup>th</sup> of November 2020, Woomera Mining Limited (ASX:WML) (**Woomera** or **the Company**) is pleased to announce that it has commenced RC drilling at its 80% owned (20% Cazaly Resources Limited ASX:CAZ) Mt Venn Gold Project (**Mt Venn**) in the Eastern Goldfields of Western Australia (**Figure 1**).
