

June 2024 Quarterly Activities Report

Progress on sale of Robe Mesa Iron Ore Project

Site activities continue at Robe Mesa and exploration set to commence at Croydon Gold and Buddadoo VTM Projects

Robe Mesa Transaction

- CZR to receive \$102m cash consideration (Purchase Price) from Miracle Iron Resources Pty Ltd (Miracle Iron) for its 85% interest in Robe Mesa, equal to approximately 43c per CZR share (undiluted shares on issue, excluding costs and taxes)
- Chinese National Development and Reform Commission (NDRC) approval granted for the transaction to proceed. Post quarter end, second Chinese Government consent granted with the Ministry of Commerce, Peoples Republic of China (MOFCOM) approving the Robe Mesa transaction
- Foreign Investment Review Board (FIRB) approval remains an outstanding condition precedent to the transaction. FIRB requested a further extension to the statutory deadline to 31 July, 2024, which was granted by Miracle Iron. Post quarter end, FIRB requested a further extension to the statutory deadline to 31 August, 2024 which has been granted by Miracle Iron
- Miracle Iron has advised CZR that as at the date of this announcement there are no outstanding requests for further information from FIRB on its application
- CZR and Miracle Iron have agreed to extend the transaction Sunset Date to 31 August, 2024 for the satisfaction of the outstanding conditions precedent to the transaction

Exploration and Development

- Heritage surveys completed at Robe Mesa to support commencement of mining operations
- Haul road access track constructed and geotechnical and civil engineering site inspection completed, linking Robe Mesa to the Northwest Coastal Highway and export markets
- Heritage survey completed at Buddadoo Vanadium-Titanium-Magnetite (VTM) deposit, with clearance received to commence JORC Resource definition drilling in Q3
- Heritage survey scheduled for late July at Croydon ahead of further drilling in existing gold mineralisation at Top and Bottom Camp, and new targets along the eastern trend, along strike from De Grey Mining's 10.5Moz Hemi gold discovery

Corporate

- \$0.6 million cash at end of June quarter
- Miracle Iron remains committed to fulfill its transaction obligations relating to Robe Mesa and Ashburton Link
- Loan facility extended with entity associated with Mark Creasy to drawdown up to \$0.5 million

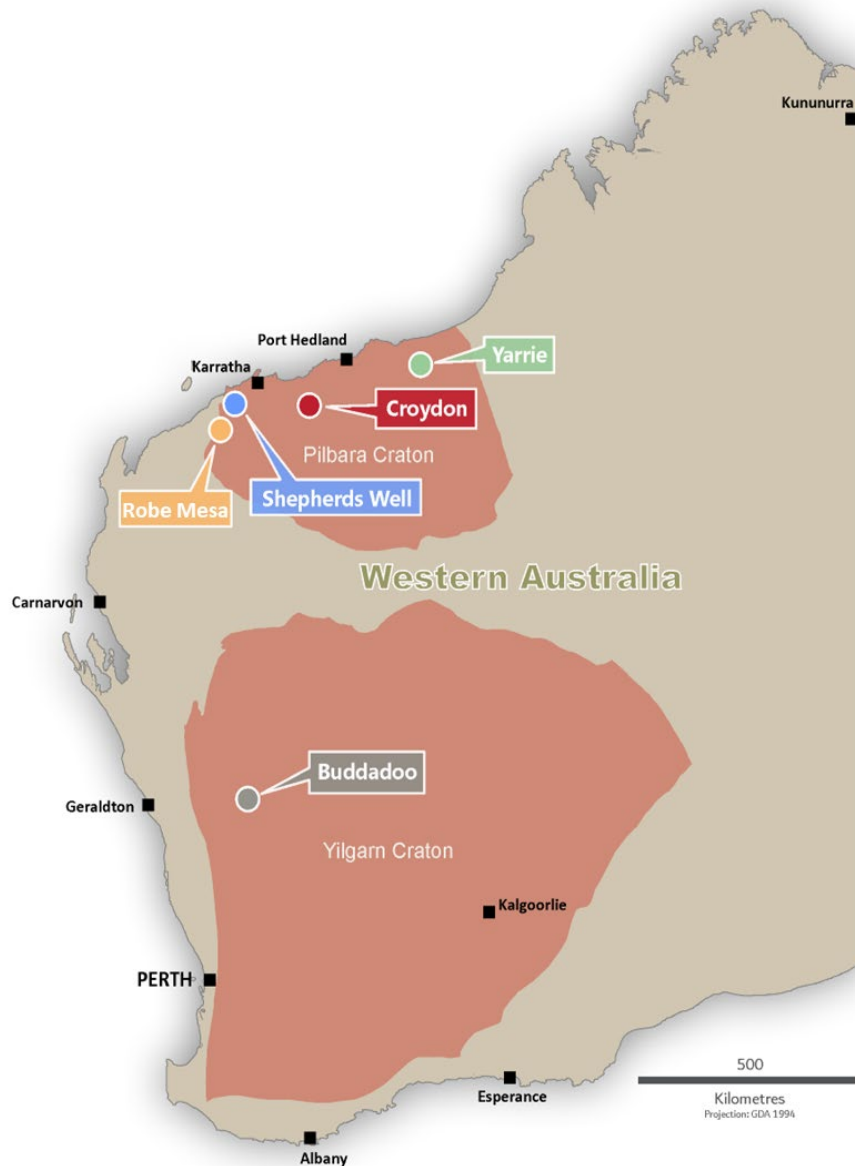


Figure 1. Location CZR projects in Western Australia

OVERVIEW

CZR is a Western Australia focused mineral exploration and development company with five projects, all in joint-venture with its major shareholder, Creasy Group. All projects are strategically located, proximal to infrastructure and cover prospective geology with established iron ore, gold and base metal endowment.

CZR’s primary development asset is the Robe Mesa iron ore deposit, part of the Yarraloola project. The Company announced the results of the Definitive Feasibility Study (DFS) in October 2023, targeting a production rate of 3.5Mtpa - 5Mtpa over an initial 8-year mine life (ASX announcement 10 October 2023).

On 11 January 2024 CZR announced it had entered into a binding share sale agreement with Miracle iron Resources Pty Ltd to sell its 85% interest in Robe Mesa and supply chain infrastructure for \$102 million.

In addition to the development of Robe Mesa, CZR is also progressing several prospective exploration projects – well located in close proximity to major mines, discoveries and infrastructure.

ROBE MESA IRON-ORE DEPOSIT (Yarraloola Project) (CZR 85%)

Location

The Robe Mesa deposit is adjacent to the Robe River JV operations (Rio Tinto 53%, Mitsui 33%, Nippon Steel 14%) operated by Rio Tinto. Rio Tinto has been mining the Robe Valley since the 1970's and has current mining operations at Mesa A, B, C, H, J and Warrambo, with rail linking to export facilities at Cape Lambert.

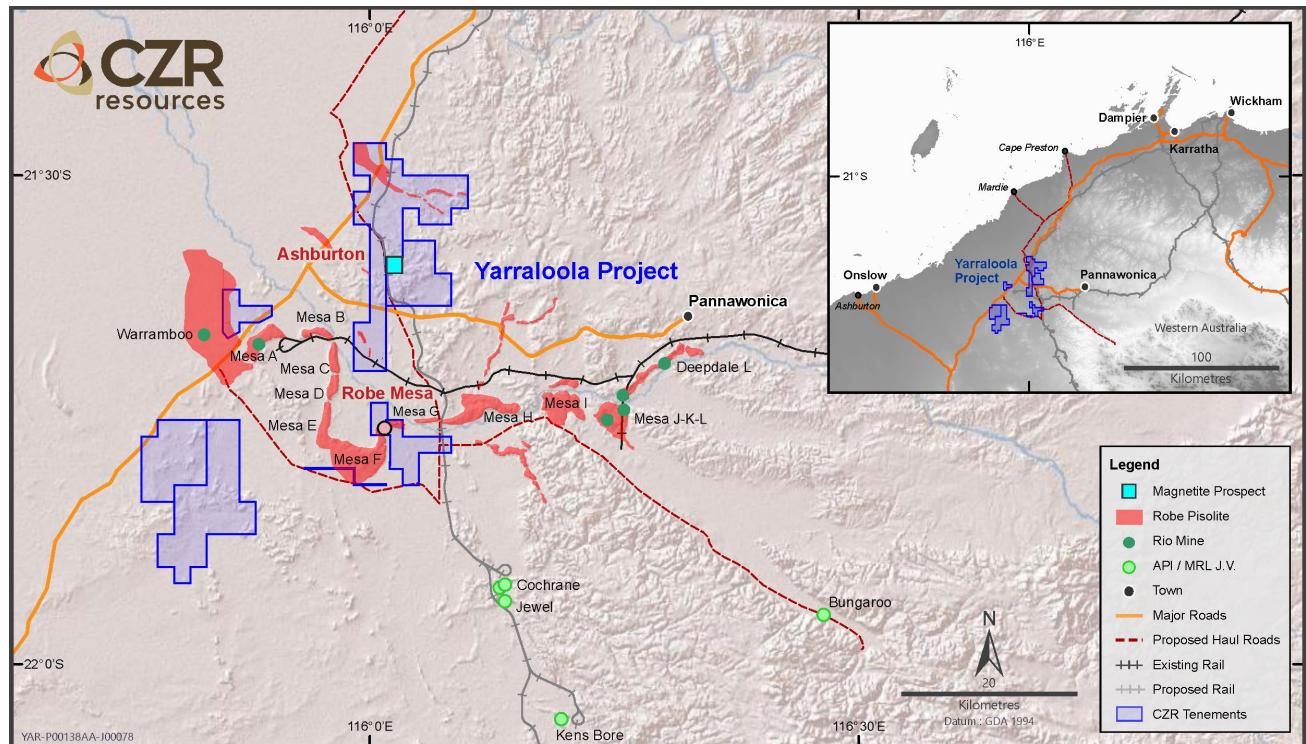


Figure 2. CZR's Yarraloola project and Robe Mesa deposit showing local infrastructure and iron ore deposits. Insert map showing regional infrastructure of the West Pilbara, relative to the Robe Mesa deposit

Miracle Iron Resources Transaction

On 11 January 2024 CZR announced it had entered into a binding Share Sale Agreement (the **Agreement**) for the sale of Zanthus Resources Pty Ltd (**Zanthus**), a wholly owned subsidiary that controls an 85% interest in the Robe Mesa Iron Ore Project (**Project**), to Miracle Iron Resources Pty Ltd (**Miracle Iron**) for \$102 million (the **Transaction**).

The transaction is subject to certain conditions precedent (**CP**), with a key condition achieved on 28 February 2024 when CZR shareholders voted overwhelmingly in favor of the transaction.

CZR has been informed by Miracle Iron that two Chinese Government approval CP's have now been achieved, with the NDRC approval received during the quarter and MOFCOM approval received post quarter end.

Foreign Investment Review Board (FIRB) approval remains an outstanding CP to the transaction. During the quarter Miracle Iron received a request for extension of the statutory deadline to 30 June, 2024, and then subsequently to 31 July, 2024. Post quarter end, Miracle Iron received a further request for extension of the statutory deadline to 31 August, 2024. In consultation with CZR, Miracle Iron agreed to the extension of the statutory deadline to 31 August, 2024.

Miracle Iron has advised CZR that as at the date of this announcement there are no outstanding requests for further information from FIRB on its application.

As a consequence of the delay with FIRB approval, the parties agreed to extend the Sunset Date to 31 August, 2024 for the satisfaction of the outstanding conditions precedent to the transaction.

Post completion of the proposed sale of the Robe Mesa Iron Ore Project to Miracle Iron, CZR will be well funded and will retain its high-quality Croydon and Buddadoo exploration assets in WA.

Development Activities

During the June quarter, site activities focused on completing heritage surveys and constructing the access track for the Robe Mesa Haul Road, linking the mining area to the Northwest Coastal Highway and export markets.

During April and June 2024, archaeology and ethnographic surveys were completed with Traditional Owners from Robe River Kuruma Aboriginal Corporation (RRKAC), covering the mining and infrastructure footprint of Robe Mesa, and additional drill lines for the Robe Mesa South deposit (acquired from FMG: ASX announcement 3 March 2023). All surveys have now been completed covering the disturbance footprint for mining and site infrastructure. Planning is underway for additional heritage surveys outside of the mining and infrastructure impact area to identify and implement monitoring practices away from the direct disturbance footprint.

An important infrastructure goal was achieved during the quarter, with the construction of the 38km haul road access track, linking the Robe Mesa mining area to the Northwest Coastal Highway and export markets. The earthworks were completed by Guma Warnii, a Robe River Kuruma affiliated contractor, with the assistance of Traditional Owners from RRKAC. In late May, CZR conducted a site investigation with its geotechnical and civil engineering consultants and have developed the next phase of geotechnical sampling and testing for suitable material (gravel base) for the haul road construction.

A comprehensive feature survey was also completed at the proposed Robe Mesa Haul Road - Northwest Coastal Highway intersection, and Onslow Hub – Onslow Road intersections. CZR civil engineers have commenced intersection designs for submission to Main Roads WA (MRWA). The intersection designs will provide for larger and lower cost super and ultra-quad road trains to haul iron ore from Robe Mesa to the Port of Ashburton, subject to MRWA final approval.

Ashburton Link

The Ashburton Link consortium continue to progress the Development Application for the Port of Ashburton Export Facility with the Pilbara Ports Authority. A tender process is underway for the engineering, procurement and construction (EPC) of the facility, with shortlisted parties participating in a final request for information, prior to tender award (anticipated mid Q3 2024). Ashburton Link continues to engage with and work collaboratively with key stakeholders and looks forward to developing the proposed 5Mtpa iron ore export facility once all approvals and contracts are in place.

CROYDON GOLD PROJECT (CZR 70%)

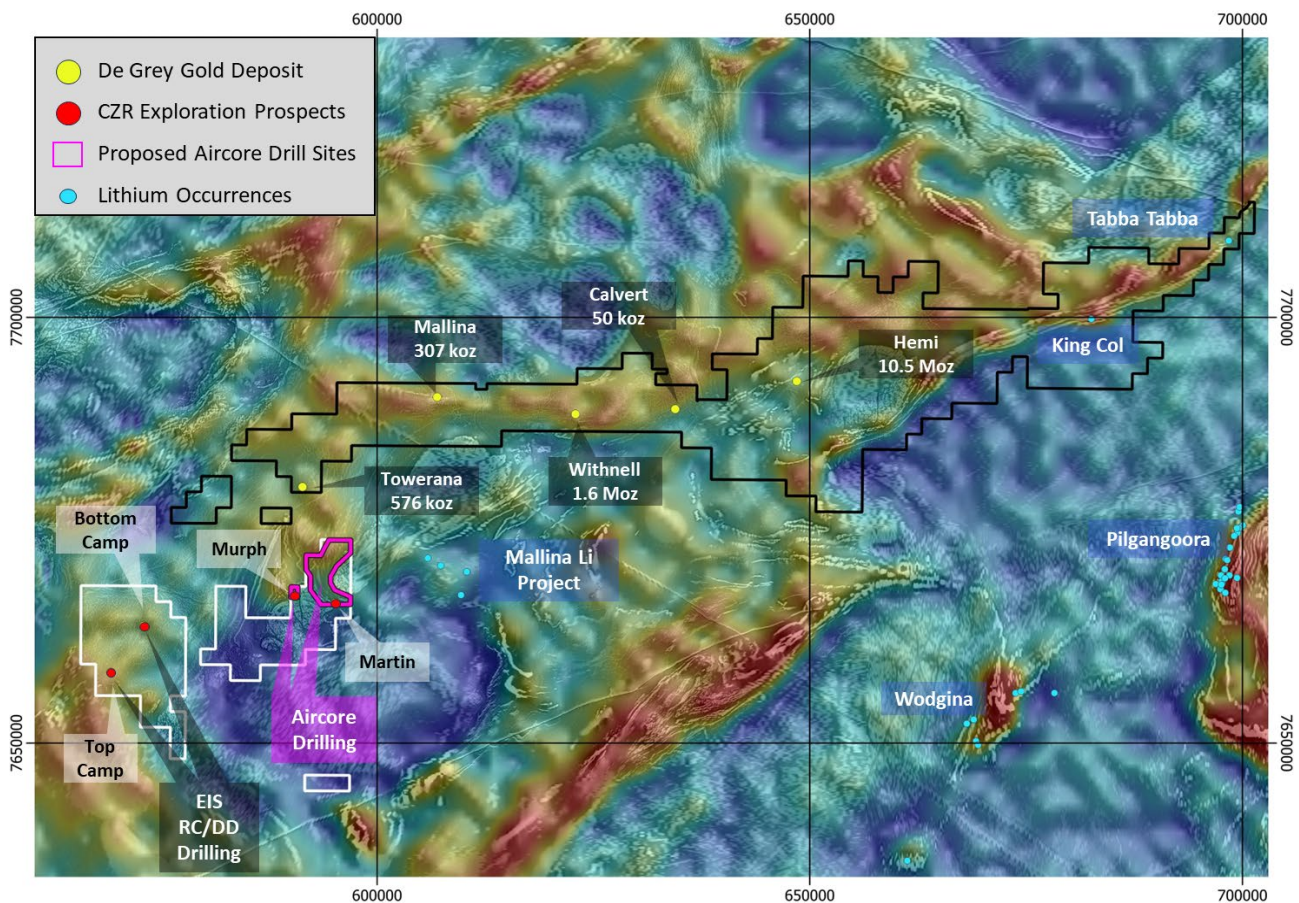


Figure 4. CZR’s Croydon project and De Grey Mining’s Hemi Gold Project – Regional gravity over magnetics

The Croydon project is located in the Mallina Basin between Karratha and Port Hedland. The region contains De Grey Mining Limited’s (DEG) Hemi gold deposit with a Mineral Resource of 10.5 Moz (DEG release to ASX; 21 November 2023). The Mallina Basin is emerging as a major gold province and CZR’s Croydon project covers approximately 40km strike of the Mallina Basin, ~50km south-east of Hemi (Figure 4).

The region is also an established lithium province, with mining operations at Wodgina (Mineral Resources) and Pilgangoora (Pilbara Minerals). Wildcat Resources’ Tabba Tabba and De Grey Mining’s King Col deposits are located along a similar geological trend northeast of CZR’s Croydon project, and Morella Corporation Limited’s Mallina lithium project earn-in with Sayona Mining is located only 10km east of CZR’s Croydon project.

As previously announced, CZR was successful in its government co-funded exploration drilling application, covering targets identified at the Top Camp and Bottom Camp prospects (Figure 4). Ground based gravity survey completed in late 2022 identified potential Hemi-style intrusions beneath known gold mineralisation in the overlying Mallina Basin sediments. CZR also anticipates drilling these targets towards the end of the September quarter.

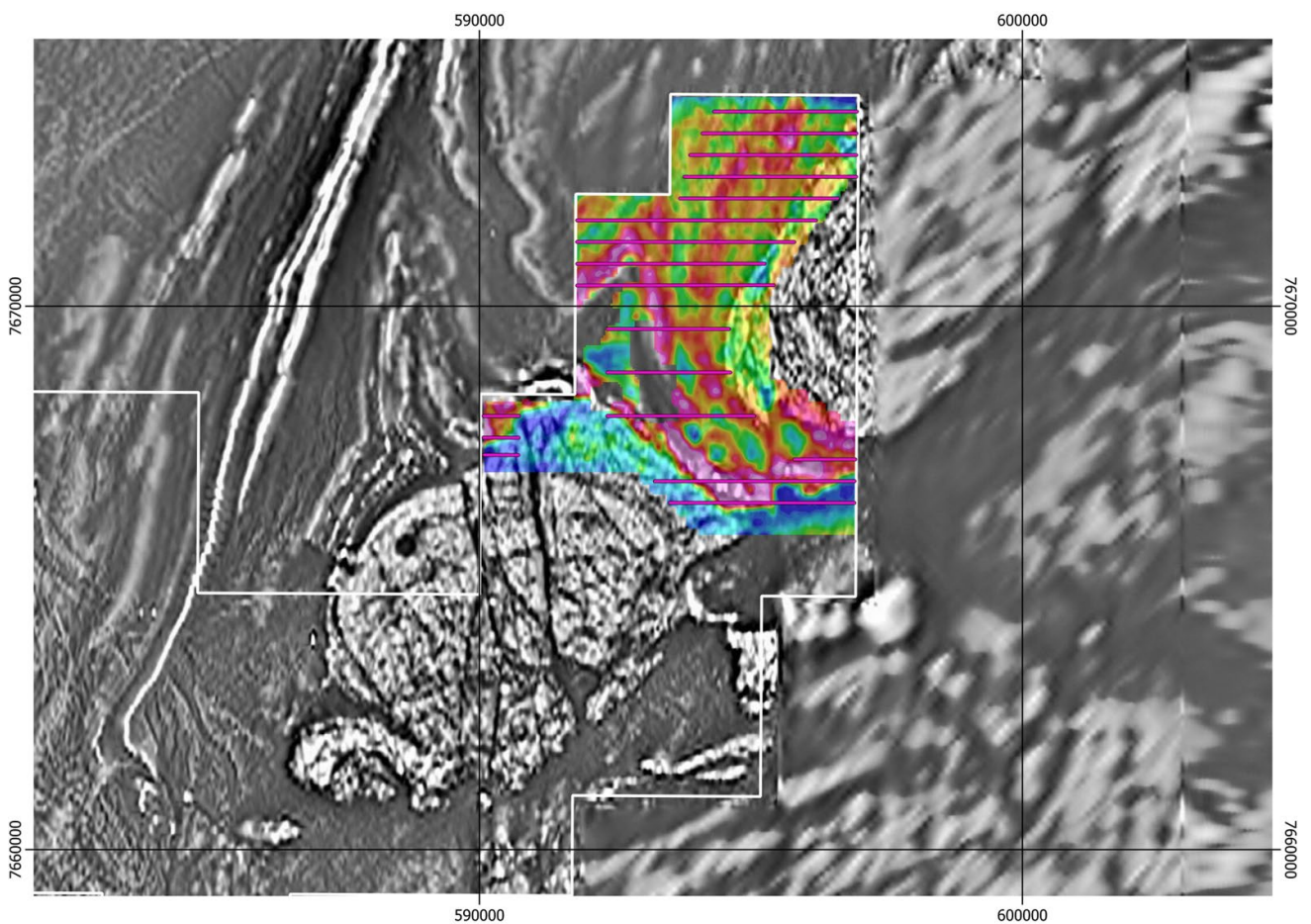


Figure 5. Proposed aircore drill lines – Eastern Gold Targets. Base image is ground gravity over magnetics, with primary target the gravity high trending north-northeast

No field activities were undertaken at Croydon during the quarter. CZR has been working with Ngarluma Aboriginal Corporation (NAC) to arrange for a heritage survey at Croydon, covering an extensive aircore drilling program, targeting greenfield gold discoveries analogous to Hemi while building our understanding of the basement geology below shallow sand cover. The heritage survey commenced post quarter end on 30 July 2024 and CZR anticipates commencing site works and drilling towards the end of the September quarter (Figure 4 and 5).

BUDDADOO PROJECT (CZR 85%)

The Buddadoo Project covers 125km² approximately 200km east of the port of Geraldton in the mid-west region of Western Australia. The project hosts copper, gold and vanadium-titanium-magnetite (VTM) mineralisation, with the most advanced prospect being a 6km long by 300-500m wide zone of gabbro with massive and disseminated VTM (Buddadoo Mafic Complex).

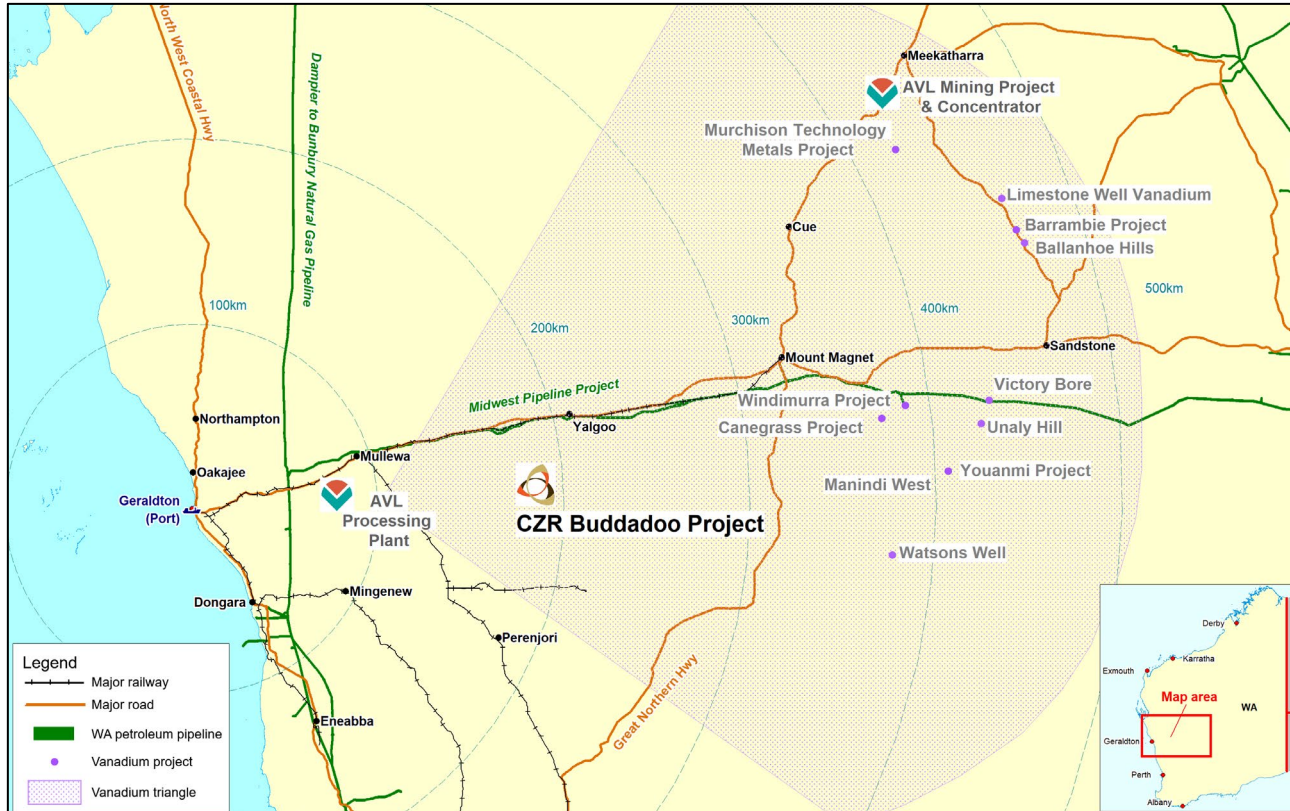


Figure 6. Buddadoo Project – regional scale showing proximal vanadium projects and infrastructure

The Mid-West region is experiencing an increase in VTM development. The recently completed \$217 million merger between Australian Vanadium (AVL) and Technology Metals Australia (TMT) (ASX Announcement 22 January 2024) provides further evidence of the region’s potential to become a significant source of vanadium production.

During the quarter, CZR completed a heritage survey over the Buddadoo Mafic Complex, and clearance has been received to commence site works. The heritage survey focussed on 200m infill drill lines over the 6km long high grade VTM trend. The infill lines will allow for resource definition RC drilling to commence, with site works scheduled to start post Robe Mesa transaction completion.

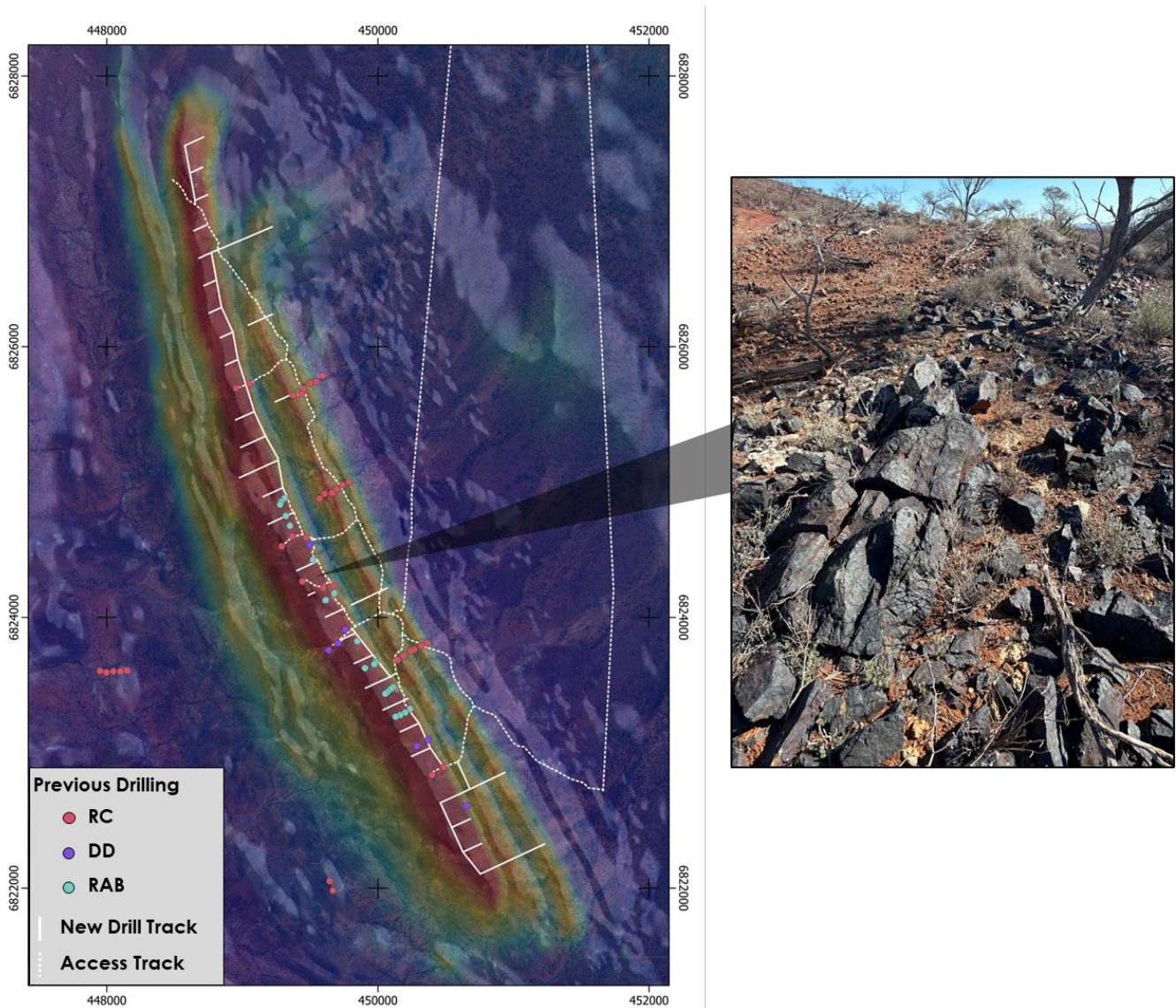


Figure 7. Buddadoo Project – 6km long magnetic trend (LHS) with existing drilling and planned drill lines. Outcropping vanadium-titanium magnetite along the magnetic trend (photo RHS)

Outcropping magnetite has been observed along the entire VTM trend, consistent with previous drilling and shows a very strong correlation with the airborne magnetic trend (Figure 7). Given the strong correlation between the high-grade VTM observed from drilling, outcrop and the magnetic response, CZR has engaged geophysics consultants to complete magnetic inversion modelling of the Buddadoo Mafic Complex. The results of this, coupled with the drill hole data, will allow CZR to quantify an Exploration Target and refine the upcoming resource definition drilling program.

As previously announced, CZR has lodged a Mining Licence application covering the Buddadoo Mafic Complex (MLA 59/784) and has commenced discussions with the Yamatji Southern Regional Corporation (YSRC), representing the Yamatji Nation native title holders over the Buddadoo project. CZR thanks representatives and members of YSRC for assisting in the recently completed heritage survey and looks forward to concluding the mining agreement in the near future.
