ISSUE OF ENTERPRISE URANIUM LIMITED SHARES – SECONDARY TRADING NOTICE NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 (Act)

On 28 February 2013, Enterprise Uranium Limited (**Company**) issued 50 fully paid ordinary shares at an issue price of \$0.25 each (**Securities**).

Secondary Trading Exemption
